NEVER GO ON ICE THAT YOU DON'T KNOW ANYTHING ABOUT!

Is the ice safe?

Stay away from stickups, like brush logs, plants or docks.
Stay away from multiple pressure cracks.
Spread out because crowds can add too much weight in the same area.
Be extra careful on rivers and streams. The ice may look thicker than it really is, because moving water wears ice from underneath. Ice may not be the same thickness all over.

Make sure you study the ice safety chart, so you know when it is safe to go on the ice!

ICE THICKNESS CAN SAFELY SUPPORT

4 inches – 200 pounds
5 inches – 800 pounds
7 inches – 1,500 pounds
8 inches – 2,000 pounds

CANDIDATE DECLARATION AND IMPORTANT VOTER INFORMATION for Upcoming Town & School Elections and Meetings

Tuesday January 8, 2019 by 12 noon – Town Petitioned Warrant Articles are due at the Selectmen's Office, Town Hall, 295 Main Street.

SAU 83 is accepting School District petition articles, contact them for time of filing. The deadline of January 8, 2019 is the same for both Town and School articles. Any petition articles will be discussed at the Public Budget Hearing on Wednesday January 9th (see Budget Committee article).

Tuesday January 22, 2019 - Last day for new registrants who want to register prior to Candidate Declaration Period. Supervisors of Checklist will meet from 7:00 to 7:30 pm at the Fremont Public Library. Town Clerk is open 7:30 am to 3:00 pm. **This is the last time to register to vote prior to the Deliberative Sessions. If you are not registered, you cannot vote at either Town or School Deliberative Session, as same day voter registration is NOT AVAILABLE for Deliberative Sessions.**

Please bring proper ID and proof of residency to register to vote and to all elections. The State has tightened up the forms, and if you don't have an ID with a Fremont address on it, you will need to bring documentation from form Verifiable Action of Domicile RSA 654:7V (available on the Town's website, from the Supervisors at a sign-up session or from the Town Clerk.)

TOWN & SCHOOL ELECTIONS - CANDIDATE DECLARATION PERIOD

The filing period for Town and School District Offices begins on Wednesday, January 23, 2019 and runs through Friday, February 1, 2019. You can sign up during any Town Clerk Office hours. On Friday February 1, 2019 the Town Clerk and School District Clerk will be available from 3:00 to 5:00 pm for sign-ups only, at the Fremont Town Hall.

You must be a Fremont resident and a registered voter to declare Candidacy for Town or School District Office. You can register to vote with the Town Clerk during regular office hours and also with the Supervisors of the Checklist during posted sessions.

Town Reports will be available in early March 2019. You can pick one up at the Town Hall, Library, or Safety Complex during normal business hours.

Supervisors of the Checklist will meet on Saturday, March 2, 2019 at the Fremont Public Library from 11:00- 11:30 am for final correction of the checklist before Town Election Day on Tuesday, March 12, 2019 from 7:00 am to 8:00 pm. (This is the final day for registration until Election Day.)

TBD 2019 - Candidates Night at 6:00 pm

Monday March 11, 2019 - Last day for the Town Clerk to accept completed absentee ballots. Clerk is open 9:00 am to 12 noon for all business; and from 3:00 to 5:00 pm for ABSENTEE BALLOTS ONLY.

Tuesday March 12, 2019 - TOWN and SCHOOL ELECTIONS

Polls open 7:00 am to 8:00 pm at Ellis School - 432 Main Street in Fremont.

Requests for Absentee Ballots shall be made in advance, through the Town Clerk.

New voters can register with the Supervisors of the Checklist on the March 12th election day.

Friday March 15, 2019 - Last day for any person for whom a vote was cast to apply to the Town Clerk for a recount. Clerk will have special hours from 3:00 to 5:00 pm for that sole purpose.

Tuesday March 19, 2019 - Last day for 10 voters of a town to petition Clerk to recount ballots on any question printed on the official ballot.

Friday March 22, 2019 - Last day for candidates for Town office to remove political advertising.



WINTER PARKING BAN IN EFFECT

According to the Town of Fremont Parking Ordinance: It shall be unlawful for any person to stop, stand or park a motor vehicle at any time contrary to any of the following provisions of this Section unless otherwise directed by a Police Officer.

1. Within the Town of Fremont, from November 15 to April 1, no parking is permitted on any public street of any town-owned right of way, or in any town-owned parking lot between 12:00 midnight and 6:00 am.

2. In the event of a winter snowstorm requiring snow plowing and/or removal as deemed necessary by the Fremont Road Agent, it shall be unlawful for any person having custody and/or control of any vehicle to park or cause the same to be parked within the public right of way during a snow storm. Vehicles interfering with snow plowing or removal operations shall be towed at the owner's expense.

Penalty: a person violating any provision of this Ordinance shall be punished by a fine or not more than one hundred (\$100) dollars for each offense, except that optional procedures set forth in this section may be used in lieu of court proceedings for violations of this Ordinance.

PORTABLE GENERATOR SAFETY GUIDELINES

Always read, follow and maintain the generator according to the manufacturer's operating instructions.

Portable generators should be placed at least 10 feet from any structure, with the exhaust facing away from the building openings. Deadly exhaust fumes can enter the building through any opening resulting in severe injury or death to unsuspecting occupants. Always use a battery powered Carbon Monoxide Detector inside your home during a power outage.

Never place portable generators on or near combustible surfaces such as decks, porches, or tool sheds. Heat generated by the motor, or improper refueling methods can start a fire.

Never run portable generators inside any building, including basement areas and garages. Deadly levels of carbon monoxide can build up in minutes injuring occupants with little to no warning. Allow plenty of time to cool the generator before refueling. Gasoline vapors can easily ignite from hot surfaces causing a flash fire and severe injuries.

Always store approved gasoline containers a safe distance from generators while in use. Always store gasoline in approved containers and placed in a well-ventilated storage area.

Never store gasoline products in basements or enclosed areas of your dwelling.

Never modify or construct any power cord so a generator can be connected to a receptacle, dryer or range outlet.

Never connect a generator directly to panelboard without a means to prevent inadvertent connection to the normal supply system wiring. Connecting a generator directly to an electrical outlet or to a panelboard without a transfer switch or an interlocking device could result in a situation where power from the generator could energize the utility's wiring (back feeds into the utility system). Electrical power from a generator back fed through your meter into the utility system can cause fires, serious injury or death to utility workers trying to repair the lines in the street, or electricians working on nearby property's electrical systems.

WASTE MANAGEMENT

The Town's contract with WM expired at year end 2018 and a four month extension has been negotiated so that we have trash and recycling services through May 1.

Very important this year on the Town Meeting Warrant is a new contract for the Town's trash and recycling collections. Due to changes in the default budget law preparation, the contract must be approved by voters in order that the annual 3% increase becomes part of our operating budget for the ensuing years of the contract. The Town put this work out to bid last September, and the Selectmen have accepted the proposal from Waste Management for a five year contract as the lowest cost option for the Town. There are new provisions of the contract including a processing cost monthly. The more acceptable recycling we do, the less these costs should be. Waste Management also had a lower base price, with only 3% annual increases instead of 5%.

WASTE MANAGEMENT RECYCLING

Recently Waste Management has reached out to let the Town know of some changes that have been made regarding the items we recycle.



When we export the recycled items, there is a stricter quality control needed and Waste Management will be checking the quality of items sent. There is an updated Acceptable Materials List, simply stated they **accept PET bottles and containers with the symbol #1, #2 and #5. Tin and Aluminum Cans, Beverage Cartons, Paper, Cardboard and Brown, Clear or Green Glass Bottles. All plastic, glass and metals should be clean and empty.**

This list and the common contaminants sheet are published at the end of this newsletter. We are having these printed in bulk to have available and will also be putting them on the Town's website.

Nothing else should go in the recycling bin, especially plastic bags, even if they have the recycling emblem on them. We also recently learned that flower pots, and the plastic "six pack" that annual flower come in, are also NOT recyclable even if they show the recycling symbol. This has to do with size and processing limitations. No types of Styrofoam are recyclable in Fremont, even with the recycling emblem on them.

Recycling has become a challenge as there is not much of a market for the plastic recyclables now. The most important thing with recycling is to not contaminate the recycling with other items that are no longer accepted. The Town saves money if we can follow these updated guidelines effectively.

We appreciate your cooperation, as the more we can properly recycle, the more we can reduce our tipping costs at the landfill.

HISTORY OF FREMONT, NH
OLDE POPLIN

The first outside town Christmas tree illuminated with electric lights, was set up near the town hall in 1946. For many years during the 1950's and 1960's, Arthur Bean illuminated the World War II Veterans Memorial Spruce Tree (planted in 1946) outside the People's Methodist Church. After a few years' absence during the 1970's and early 1980's, the church again began the custom of illuminating this tree. They have proudly continued the tradition to this day.

Sleigh Riding

Sleigh rides were once a popular and necessary form of traveling. It was common for local families to bundle up and pile into a one or two town horse sleigh to go joy riding around the beautiful snowy Fremont countryside. At night, lanterns and sleigh bells were used to warn approaching traffic of sleighs that glided swiftly and quietly along hard, snow-packed country roads. Sleighs full of passengers could be heard singing as they merrily glided along their way.

REGISTER TO EARN AN ADULT HIGH SCHOOL DIPLOMA

The Exeter Adult Diploma program is now registering students for the Winter Spring 2019 semester courses that begin the end of January. This program is designed for students who did not complete high school but who would like to earn a diploma by taking courses in the evening similar to those taken by high school students. Classes are small and are offered Monday, Wednesday and Thursday evenings.

Adults interested in this program should call the Adult Education office ASAP at 603 775 8457 to arrange an appointment sometime in January. Prospective students are asked to bring a copy of their high school transcript and certificates of any other training in order to evaluate how many credits they have already earned. In addition, older students may also qualify for work experience or military credits.

The selection of courses this semester includes: Mondays: Biology with lab, Real World Math and English. Wednesdays: Developing College Reading Skills (English) at Great Bay Community College- starts January 23rd. Thursdays – Chemistry with lab, Energy & Motion and Global Human Rights/Economics. Limited scholarships are available thanks to the generous support of the Exeter Rotary Club and Exeter Lion's Club.

These courses are also open to adults who have completed high school but who also would like more background in a given subject area. Many adult students take these courses to prepare themselves for college courses. Anyone interested in taking courses in the Diploma Program should call as soon as possible, as these classes have limited enrollment, and pre-registration is required.

ENGLISH-ESL CLASSES FOR ADULTS

Exeter Adult Education welcomes non-native speakers of English to join English for Speakers of Other Languages (ESL) classes. Beginner through advanced English language learners can improve their English speaking, listening, reading, writing, grammar and pronunciation skills. Multiple levels of instruction are offered.

Participation in ESL classes provides a wonderful opportunity to meet other adults from around the world and to make new friends.

ESL classes are held at Exeter Adult Education at the Tuck Learning Campus, Entrance D, 30 Linden Street, Exeter. Day classes meet Monday, Wednesday, and Friday mornings from 9:00 - 11:00 a.m. Evening classes meet Monday and Thursday from 6:30 to 9:00 p.m. ESL class placement is determined by an intake assessment, so all prospective students should plan to attend registration day.

Classes are free and open to all NH residents.

The first registration for day and evening classes for 2019 is **Monday, January 7th at 9:00 a.m.** for day program and **6:30 p.m.** for the evening program.

HIGH SCHOOL EQUIVALENCY and ACADEMIC SKILLS COURSES OFFERED

HiSET® (High School Equivalency Test) has replaced the GED in NH and many other states. Like the GED, it provides an opportunity to study for and earn a New Hampshire high school equivalency certificate.

Adults who did not complete high school or who need to improve reading, writing, or math skills for personal or professional growth are encouraged to come back to school. Because school may not have been a positive experience the first time, returning to school may sound uncomfortable. Yet many adults from ages 18 to 75 have taken the courageous step to get their high school equivalency certificate or to improve their writing, reading, and math.

Some people come to school because they need a high school equivalency or other certification to get a job or to prepare for job training or college. Others want to be able to help their own children but need to improve their own skills first. Whatever the reason, it's not too late, and Exeter Adult Education staff can help each step of the way.

Adult Academic Skills and HiSET Preparation day classes meet on Monday, Wednesday, and Friday from 9 a.m. to noon. Evening classes meet on Monday and Thursday from 6:30 - 9:00 p.m. The first Fall session registration is on **Monday, January 7th at 9:00 am for day classes and 6:30 pm for evening classes.**

Most Common Contaminants

NO Electronics & Small Appliances

Donate if in good condition, or schedule a bulky item pickup, if available. Check earth911.com for a local drop off site.



NO Textiles, Bedding, Rugs & Carpet

Donate these items if they are in good condition. Large quantities may require special disposal.



NO Hoses, Holiday Lights, Hangers & Extension Cords

They wrap around equipment and can shut down an entire facility! They all go in the trash.



NO Plastic Bags, Film/Sheeting & Flexible Film Packaging

Take plastic bags back to a local grocer to keep bags clean and dry, and prevent them from shutting down recycling facilities. Visit plasticfilmrecycling.org to find a drop off location near you.



NO Paper Napkins, Plates, Cups & Tissues

Compost if possible, and remember to recycle the cardboard tube.



NO Polystyrene Foam

Foam and plastic to-go containers are not recyclable curbside. Find drop off programs for items like foam packing peanuts at earth911.com.



NO Tires, Auto Parts & Scrap Metal

(Not in recycling or trash) Can damage equipment & are safety hazards. Contact local scrap recyclers or retail tire stores for recycling options, or check earth911.com for a drop off center near you.



NO Concrete, Wood & Construction Debris

Can damage equipment & are safety hazards. You may be able to schedule a bulky item pickup - otherwise throw it in the trash or order a roll off bin by contacting Waste Management Customer Service.



NO Medical Waste (Find safe & secure disposal near you.)



NO Non-Recyclable Plastic

Not everything that is plastic is recyclable! Recycle only food & beverage bottles, jugs and tubs.
