# SANDOWN ROAD BRIDGE – ONE LANE RESTRICTION

The Sandown Road Bridge Overflow is restricted to one lane. This bridge is the last one on Sandown Road before the Fremont/Sandown town line. Closure will affect travelers using Sandown Road, and the Fremont residents who live on the Sandown side of the closure. This includes a couple of houses on Sandown Road and anyone who lives in the Dakota Drive / Treaty Court neighborhoods.

The design and permitting work is underway. This summer (anticipated beginning in July) it will be closed for approximately two months while the work is completed.

There is signage at either end of the bridge, and only one vehicle wide will be able to traverse at once. This may cause some traffic backups and delays, please plan accordingly.

We will be working closely on mutual aid responses for emergency service with our emergency service partners from the Town of Sandown. If you have questions, please feel free to contact the Selectmen's Office at 895 2226 x 301 Heidi; x 303 Jeanne; or x 302 Kathy.

Thank you for your patience. It is the Town's goal to get this work done as soon as possible, during the period of lowest flow this summer, and while school busses are not travelling the roadway.

### CHESTER ROAD CLOSURE

Following Town Meeting approval, the Highway Department has road improvements underway on Chester Road. Please use caution in this area through mid-July. The ROAD WILL BE CLOSED for culvert work on Monday & Tuesday July 7 & 8, and for additional days thereafter, depending on the schedule for the paving company. # NH LOW & MODERATE INCOME TAX RELIEF

The State's 2018 Form DP-8 for the Low- and Moderate-Income Property Tax Relief is available. You can get a copy from the Selectmen's Office or use the web fill-in form and print it. It is also available from the Town's website. The State no longer mails the forms out, so be sure to get yours soon. Forms must be filed by June 30, 2019.

## CYCLICAL ASSESSING UPDATES

The Town's assessing contract includes cyclical updates. This means that ¼ of the Town will be reviewed each year (data and listing information) toward the goal of the every fifth-year revaluation/recertification process required by the State. The fifth year of this process for Fremont is 2020, and we will soon be ramping up our revaluation efforts. During this time, we review all exemptions and credits, Current Use maps and information, and other listing information on properties.

Assessors are out in the field ore often looking at all the housing stock. They will update photos and listing information and will ask to view your home if you are there when they visit. This is at the owner's discretion but is most helpful to the Town to ensure we have the best, most up to date information to arrive at your assessed valuation.

MRI personnel are in the field working on these properties and they carry MRI Photo Identification and have with them, a letter signed by the Town, with their name and vehicle information including license plate number. Currently Dan Scalzo is working in Fremont collection the data. The Selectmen's Office will always know when the Assessors are working in Fremont, so please feel free to call us if you have any questions. ## FIRE PERMITS REQUIRED

Please remember these simple rules:
Every person firm or corporation who kindles or causes to be kindled, any fire or shall burn or cause to be burned any material in or near the woodlands, except when the ground is covered with snow where you are burning **SHALL** obtain a written fire permit from the Forest Fire Warden in the town or city where the fire will be kindled, pursuant to NH RSA 227-L:17, I and II.

#### **CAMPFIRE PERMITS**

Camp or cooking fires may be kindled only when written permission of the landowner or agent and a written fire permit from the Forest Fire Warden. A camp or cooking fire is a suitable fire in a suitable place for the purpose of cooking a meal. A gas grill or charcoal fire in a container up and off the ground kindled by the landowner, or with landowner permission does not require a written fire permit. Contact the Fremont Fore Department to renew your seasonal campfire permit. This needs to be done on an annual basis.

#### CHIMINEA BURING DEVICES

Chiminea devices do fall under the jurisdiction of the Forest Fore Warden. In order to use these devices, you must obtain a written permit from the Warden every time you use it. The reason for this is



that the units do not meet criteria to be considered an "enclosed" device and as such are subject to the rules of open burning.

#### **RULES AND REGULATIONS**

A written fire permit shall be SUMMARILY SUSPENDED in any of the following fire permit restrictions are violated, and an Official Notice of Summons shall be issued:

If a fire is kindled or material is

burned between the hours of 9:00 am and 5:00 pm unless actually raining.

- If a fire is kindled or material is burned at an unspecified date, time, place, or if material not specified on the written permit is burned
- If a fire is kindled or material is burned when specified assistance or suppression equipment is not present to control the fire
- If permitee fails to keep the fire under control, or if the Director, Division of Forests and Lands, or his authorized agents or Warden feel that the material being burned is causing a hazard endangering life and/or property.
- If material being burned violates any state law, rule, or regulation or local ordinance and or New Hampshire Air Resources Division regulation regarding open burning.

#### OTHER REGULATIONS

- All open fires shall be constantly attended until the fire is completely extinguished
- Fires kindled, and material burned shall be no less than 50 feet from any structure and provisions shall be made to prevent a fire from spreading to within 50 feet of any structure.
- You must be 18 years of age to obtain a written fire permit
- You must also be the landowner to obtain a permit. If you are not, written permission from the landowner must be submitted to the Fire Department. This permission must clearly state the dates the owner is permitting burning (and it can be done for the "season"), who they are giving permission to, and their name, address, and contact telephone number

Be sure your fire is completely and totally extinguished.
A burned fire is not an extinguished fire!

If you have questions, please contact the Fremont Forest Fire Warden Richard Butler through the Fire Station at 895 9634 or by calling Raymond Dispatch at 895 4222. The Fire Chief/Forest Fire Warden has office hours on Monday and Thursday evenings from 5:00 to 7:00 pm, and you can call Dispatch or the Station at any time for more information.

In Fremont, burn permits are only issued in the evening, weather conditions permitting. Call the above phone numbers for more information day to day.

The class day is depicted on the Smokey Bear sin in front of the Safety Complex Station at 425 Main Street. In general, when the fire danger is at 3 or above, no permits are issued for outdoor burning. It is solely at the discretion of the Warden on a daily basis, depending on the weather conditions.

# HELP WANTED PART-TIME CEMETERY LABORER

The Town of Fremont is seeking applicants for a part-time, seasonal labor position within the Town's cemeteries. Hours generally weekdays, (some weekends possible) and schedule is weather-dependent. Suitable candidate should be a self-starter and able to work with minimal supervisions, primarily responsible for lawn care moving, trimming, leaf raking and general cemetery maintenance. Position busiest during the months of May through early July: with other maintenance throughout the growing season. Position primarily supervised by the Cemetery Superintendent. Available hours could be 10-12 hours per week, fluctuating based on needs of the Town. Days and work hours can be flexible, depending on candidate and scheduling needs. Must be 17 years of age or older. Early spring schedule is busiest, especially in preparation for Memorial Day.

Experience working with the public is preferred and landscaping/lawn equipment familiarity is necessary. Successful candidates will be required to submit to a complete background check and must be able to deal well with the public and understand the general etiquette of working in burial grounds.

### MOSQUITO CONTROL

The Town has re-entered contracts with MPMS Inc and Swamp Inc relative to mosquito control activities for the Town of Fremont. Special emphasis is placed upon the control of mosquito species that are known vectors of West Nile Virus and Eastern Equine Encephalitis.

Control of larval mosquitoes in stagnant bodies of water began in April. The primary method of control will be a bacterium (BTI) that is a naturally occurring parasite of mosquito larvae. Areas requiring control will be emergent marshes, cattail marshes, red maple swamps, woodland pools, roadside ditches, street and parking lot catch basins, marshes, flooded fields and stormwater basins. ## WASTE MANAGEMENT RECYCLING

There is an updated Acceptable Materials List, simply stated, acceptable items include PET bottles and containers with the symbol #1, #2 and #5. Tin and Aluminum Cans, Beverage Cartons, Paper, Cardboard and Brown, Clear or Green Glass Bottles. All plastic, glass and metals should be clean and empty.

This list is available at Town buildings, the website, and published at the end of this newsletter. The contaminants list is on the website and in the printer flyers at Town buildings.

Nothing else should go in the recycling bin, especially plastic bags, even if they have the recycling emblem on them. We also recently learned that flowerpots, and the plastic "six pack" that annual flowers come in, are also NOT recyclable even if they show the recycling symbol. No types of Styrofoam are recyclable in Fremont, even with the recycling emblem on them.

Recycling has become a challenge as there is not much of a market for the plastic recyclables now. The most important thing with recycling is to not contaminate the recycling with other items that are no longer accepted. The Town saves money if we can follow these updated guidelines effectively.

We appreciate your cooperation, as the more we can properly recycle, the more we can reduce our tipping costs at the landfill.
