### III. LIAISON REPORTS

**03/04/2024 Conservation Commission**: At a Public Hearing the CC approved an additional \$20,000 to bring the total estimated budget to apply a conservation easement to the Pellerin property plus 5 Townowned lots to \$60,000. This is a conservative estimate and includes ~\$20,000 to be paid for by Grant Bay Resource Protection Program grant money. The CC plans to apply for a Moose Plate grant later this year for the remaining \$40,000.

The CC has recommended the Select Board reappoint Leanne Miner and William Knee as members serving three year terms (2024-2027). The CC has recommended the Select Board appoint Ellen Douglas as an Alternate member for a three year term (serving 2024-2027). This brings the CC to a total of 5 active members and 2 alternate members.

Tavern Road Extension Road Upgrade and Oak Ridge Timber Harvest – Road improvements are stalled at the NHDES wetland permit stage. Timber Harvest Plans are pending permit approval.

Pellerin Property Conservation Donation – Map 3, Lot 59 on Beede Hill Road – Work remaining includes site survey and legal processes. Anticipated completion date is June 2024.

The CC applied for and is scheduled to receive technical assistance through Connect to Protect team at UNH as part of their NH Coastal Watershed Conservation Plan. Technical assistance will include training in GRANIT database updates for conservation purposes. This benefit of Technical Assistance is estimated to be worth \$1,200 to \$1,500.
