PUBLIC INPUT SESSION FOR MASTER PLAN VISIONING CHAPTER

In accordance with NH RSA 91-A: 2, II, you are hereby notified that the Fremont Planning Board will meet in the main floor meeting room at the Fremont Town Hall at 7:30 pm on Wednesday May 2, 2012, and at 10:00 am on Saturday May 5, 2012 to conduct a Public Input Session for Amendment of the Visioning Chapter of the Fremont Master Plan.

What is the Master Plan?

The Master Plan is a document that details specific information about Fremont. It is both map and compass to navigate the community's future. The Master Plan is a collection of chapters that deal with many topics including community goals, natural resources, community facilities, public utilities, housing, historic resources, transportation, land-use, future land-use and growth management. The Master Plan is not a static document but rather a living one that grows and changes to meet the changing needs of the community.

Why is it important?

The Master Plan is the critical document for the long range planning for the Town. It is the primary source of information upon which landuse regulations are based.

Who is involved?

The Fremont Planning Board is responsible for updating the Master Plan chapters every five years. The Rockingham Planning Commission has been contracted to help prepare an amendment to the current Visioning Chapter of the Master Plan.

Input is important from citizen groups, civic organizations, Town officials, members of Town boards and all

residents of the Town of Fremont.

You are invited to come and participate in one or both public input sessions.

DOG LICENSE REMINDER

2012 dog license tags are available. A current rabies certificate is required for licensing your dog(s). The Town Clerk's Office is required by law to retain a copy of the vaccination certificate. Please call the office to inquire if the rabies certificate on file is still valid.

You must license your dog(s) by April 30th to prevent the initiation of a late penalty of \$1.00 per month. As required by RSA 466:1, all dogs must be licensed each year by April 30th. For your convenience, the license(s) can be mailed for an additional fee of \$1.00 per license, or you can license your dog(s) online by going to the Town Clerk page on the Town's website at www.Fremont.nh.gov and click E-Dog.

FREE CANCER SCREENINGS OFFERED AT FAMILIES FIRST

Families First Health and Support Center, the Seacoast's community health center, will offer free breast and cervical cancer screenings for eligible women on the evening of June 6, 2012. The clinics include Pap smears and breast exams, with referrals for free mammograms at a choice of mammography centers.

To be eligible for these screenings, a woman must be age 40 or older; have no health insurance, or have health insurance with a high deductible; and meet household-income guidelines – for example, an annual income under \$28,000 for a single woman. Women younger than 40 who haven't had a Pap smear in more than three years are also eligible.

Space is limited, and appointments are needed. To make an appointment, call Jane Cummings, RN, at 603-422-8208 ext. 222.

Physician Kareen Worrell, DO, is volunteering her services to provide the screenings. The cost of the tests is covered by the State of NH's Breast and Cervical Cancer Screening Program.

NH LOW & MOD INCOME TAX RELIEF

The State has not yet released the 2011 Form DP-8 for the Low and Moderate Income Property Tax Relief. Once released, these forms will be available on the State website and from the Selectmen's Office. The State no longer mails the forms out, so be sure to get yours. Forms must be filed between May 1 and June 30, 2012.

BUDGET COMMITTEE OPENINGS

There are currently two vacancies for year long, volunteer, appointed positions to the Fremont Budget Committee, through the March 2013 Town Meeting. In general, the position requires attendance at 14-16 evening meetings per year, busiest during the budget season between September and January annually; and quarterly the rest of the year.

The Fremont Budget Committee is accepting letters of interest from any Fremont resident who may have knowledge in financial matters or interest in such a position. A desire to serve the community and an interest in finances and budgetary matters of the Town and School District are a must. You must be a registered voter in Fremont.

Following the completion of this term in March, the positions return to elected terms as of March 2013. The positions remain open until filled by appointment of the remaining Budget Committee members. A special meeting will be held as soon as there is sufficient interest in the positions.

BUDGET COMMITTEE MEETINGS

The Budget Committee held their first meeting of the new budget year on Wednesday April 18, 2012. Gene Cordes was elected Chair and Charles Kimball Vice Chair. The Committee set their next meeting date for August 15, 2012 to review quarterly reports. The Committee will also meet on Wednesdays September 12 and 26 to begin their work on the 2013-2014 budget cycles. Meetings were also established for Wednesdays October 3, 10, 17, 24, and 31. As stated in the article above, the Committee may schedule, post, and hold a meeting in late spring to decide on filling the vacancies.

TAX INFORMATION

Tax bills will be coming out at the end of May for the first issue of 2012. Tax bills will be due on Monday July 2, 2012. If you have any questions about making a tax payment or interest calculations on a past due amount, please feel free to call 895-3200 x14, or email fremonttax@comcast.net.

Please be aware that tax bills are mailed only to the homeowners. If your taxes are paid through an escrow account, you are encouraged to forward you tax bill to your bank/financial institution to ensure timely payments. If you are sending in your tax payment through the mail, please include a self-addressed stamped envelope and your paid receipt will be mailed back to you. When preparing to make your tax payment in person, be advised that ONLY the Tax Collector and/or Deputy Tax Collector can stamp your bill as PAID, so please plan accordingly.

Abatements can be filed after the final tax billing of the year. If you wish to file an abatement, contact the Selectmen's Office after the December bill is sent out. Forms will be available in the fall for that purpose from the Selectmen's Office and on the Town Website.

STATE ELECTION UPDATES

The Supervisors of the Checklist will meet Tuesday June 5, 2012 from 7 - 7:30 pm at the Fremont Library for change of party registrations, corrections to the checklist and new voter registrations. This is the last day for voters to change their party affiliation prior to the September 11, 2012 State Primary.

The filing period for State Offices is June 6 – 15, 2012. Candidates for State Representative (republican and democratic) and Candidates for the Republican State Convention must file with the Town Clerk. You may file during regular office hours. The Clerk will have additional filing hours on Friday June 15 from 3:00 pm – 5:00 pm (for filing purposes only). Candidates for all other offices must file with the Secretary of State.

10 gallons or 10 pounds.
