# NEW HAMPSHIRE GENERAL ELECTION

Tuesday, November 8, 2022 with polling at Ellis School, 432 Main Street in Fremont, from 7:00 am to 8:00 pm.

Regarding Absentee Voting: Please note that the statutes, executive orders and guidance in place for the 2020 elections specific to COVID 19 and obtaining an absentee ballot have <a href="expired">expired</a>.

A person can register and vote by absentee if, based on their own health circumstances, medical authorities advise them to avoid going out in public. This applies to:

- voters with symptoms of a communicable disease or illness
- voters who, due to their own health circumstances, limit public exposure in their day-to-day life as a preventative measure.

These two types of voters can reasonably conclude that a "physical disability" exists within the meaning of RSA 654:16 and 654:17, absentee registration, and RSA 657:1, absentee voting.

You can mail, fax, email or drop completed absentee ballot application forms in the drop box and the Clerk's Office will send your ballots out. If you don't have access to a printer and need these applications mailed to you, contact the Clerk's Office or pick one up at Town Hall. Returned absentee ballots must be received by the Clerk by 5:00 pm on Election Day, November 8<sup>th</sup> for the State General Election.

Completed ballots MUST be submitted in person to the Town Clerk, or mailed. They cannot be accepted via the drop box. The Clerk's Office will be open in addition to normal hours on Monday November 7 for the State General Election from 3-5 pm for absentee ballot processing only.

## 2022 TAX RATE RELEASE

We are in receipt of the 2022 tax rate. The Select Board's Office, with input from the School District, has prepared this information for you in an effort to assist in your understanding of the 2022 rate. The new tax rate, set by the NH Department of Revenue Administration on October 19 is \$23.19 per thousand. This breaks down as follows:

This is the first year of a tax rate increase since 2019. While we did receive some unanticipated revenues, the overall spending to support the Town, School and County operations increased somewhat and the School District returned less of a fund balance than prior years. Instead they put some of the savings into trust funds to account for future needs.

The 2020 tax year was our most recent revaluation, and the next one is scheduled for 04/01/2025. The changes in values made 2020 quite dynamic, and the overall impacts of budgets and property values have settled more into the 2021 and 2022 rates.

A key component to the annual setting of the tax rate is the total amount of town-wide assessed valuation. This is the total value of all taxable land and buildings in Fremont. We did not see significant increases in values for 2022 though the increase did help to reduce the tax rate by approximately \$0.37. The values have changed as follows:

The School District has been able to return funds from unassigned fund balance which significantly works to balance the tax impacts. This year, the School District's fund balance was used to add to trust fund accounts for future use. The remaining amount \$102,230 was returned. The State School tax portion decreased by \$0.57. Both the Local and State School portions fund education within our District.

If you have specific questions about the Town's portion of the tax rate, they can be directed to the Select Board's Office at the Town Hall at 603 895 2226 x 301.

As in all years, the local tax rates (Town and School) are a direct reflection of the action and votes taken by the voters of Fremont at the annual Town and School District Deliberative Sessions, followed by March ballot voting. The Select Board, School Board and Budget Committee are currently working on the budgets for the next respective fiscal years. Budget Committee meetings are held on Wednesday evenings and are broadcast on FCTV 22 and livestreamed on Vimeo. The Public Budget Hearing will be held on 01/11/2023 at the Ellis School Gym; and Deliberative Sessions will be held beginning at 9:00 am on Saturday February 4, 2023 at Ellis School. All dates are on the website calendar.

The portion of the Rockingham County budget attributable to Fremont increased by \$17,722 to a total of \$481,701 for a rate increase of two cents.

Veteran Credits decreased by \$7,125 to \$221,375. Elderly and Disabled Exemptions increased by \$153,600 to \$2,255,000.

Current Use values did not change significantly. There was \$9,250,532 of new assessed value attributable to new homes, garages, sheds, and other property improvements. Additions to the tax base help to offset expenditure increases and more evenly balance the tax rate.

#### SECOND ISSUE TAX BILLS ARE DUE DECEMBER 1, 2022

The Tax Collector's Office at the Town Hall will be open the following dates for payment of taxes:

The Town Hall is open. You can drop your bill off while the Select Board's Office is open, or in the drop box, but you cannot get a paid receipt unless you visit the Tax Collector during open hours, or leave a stamped return envelope with your payment. In these uncertain times, you may continue to use the drop box or mail, as we check both frequently.

If you have questions about your assessment or an abatement, credit or exemption, please feel free to stop by the Select Board's Office for information. All property assessing records are public information. You can access the information online from the Town's website at

https://www.fremont.nh.gov/assessing/pages/online/property/look

We send updates in several times a year to the Vision site, and you can see the most recent date of updates when you log on. The Select Board's Office is open Monday and Friday 8:00 am to 12 noon; Tuesday and Wednesday 8:00 am to 4:00 pm; and Thursday from 9:00 am to 5:00 pm, and this is where the most current information is housed. A public (always up to date) terminal is available when the Town Hall is open. We will also be glad to mail out your property card to you, if you call or email us and make a request.

If you feel that your property is disproportionately assessed, or there are listing errors on your card, you can file an abatement. Our abatement information sheet is available at the Town Offices and on the town website at

https://www.fremont.nh.gov/assessing/pages/abatements
Abatement forms are also available at the Select Board's Office.
You need Form *Taxpayers 76:16 Abatement Application to Municipality.* You can also call or email the Select Board Office and we will send one out to you. Abatement forms are DUE no later than Wednesday MARCH 1, 2023 at 7 pm. A postmark of up to March 1, 2023 will be accepted. Postmarks after March 1, 2023 cannot be accepted. Leaving items in the drop-box after 7 pm on March 1 will not be accepted as timely.

You can drop off tax payments with a stamped self-addressed returned envelope, and the Collector will mail out your receipt. The Select Board's Office and Tax Collector's Office are located at the Fremont Town Hall, 295 Main Street; on the main floor.

## **NOTICE of PUBLIC HEARING**

The Fremont Conservation Commission with the Select Board, will hold a Public Hearing on Thursday, November 3, 2022 at 7:15PM at the Fremont Town Hall, basement meeting room, pursuant to NH RSA 36-A:4 and 5 and RSA 675:7 concerning the purchase of parcel 04-077 for conservation purposes. The parcel is 23.69 acres, located adjacent to the Glen Oakes Town Forest and fronts on Copp Drive. Funding for the purchase is proposed to come from the Fremont Land Use Change Tax Conservation Fund and will not exceed \$197,900 including all closing costs. Grant applications are in progress for up to \$120,000. If awarded, grant funds will be used to fund a portion of the total project cost.

Upcoming Town & School District 2023 Elections and Meetings

January 10, 2023 by 11:00 am – Town Petitioned Warrant Articles are due at the Select Board's Office, Town Hall, 295 Main Street.

SAU 83 is accepting School District petition articles, contact them for the time of filing. The deadline of January 10, 2023 is the same for both Town & School District articles. Any petition articles, all Town & School District budgets and Warrant Articles will be discussed at the

Public Budget Hearing on Wednesday, January 11, 2023 with a snow date for Thursday January 12. Location will depend on current conditions. The hearing begins at 7:00 pm. The meeting will be live broadcast on FCTV Channel 22 and rebroadcast through Town & School Voting on Tuesday March 14, 2023.

Tuesday January 24, 2023 is the last day for new registrants who want to register prior to Candidate Declaration Period. Supervisors of Checklist will meet from 7:00 – 7:30 pm at the Fremont Public Library. This is also the last time to register to vote prior to Deliberative Sessions. If you are not registered, you cannot vote at either Town or School Deliberative Session.

Please bring proper ID and proof of residency to register to vote and to all elections. The State has tightened up the forms, and if you need to bring documentation from form Verifiable Action of Domicile RSA 654:7V (available on the Town's website, from the Supervisors at a sign-up session or from the Town Clerk).

The filing period for Town & School District Offices begins on Wednesday, January 25, 2023 until Friday, February 3, 2023. You can sign up with the Town Clerk during office hours. 
December 15 (Thursday) at 7:00 pm The Concord Coachmen will present their Holiday Concert.

## TRASH INFORMATION

I'm cleaning out the garage and have a lot of refuse to get rid of right away. Where can I dispose of it?

The automated refuse collection program is not intended to provide this type of service. The resident must be responsible for the disposal. For larger projects Waste Management or other vendors can also provide temporary containers of varying sizes for your needs.

The Town does offer two annual BULKY drop-off events for this type of disposal. Fall Bulky Day is October 29th, don't miss it!

Your toter must allow the top to be fully closed in order for pickup. If you have bags sticking out or overflow, it will not be collected. Consider another recycling bin if you need space in your toter.

Be sure and place your toter at least three feet away from any other item, including from your recycle bin.

All trash must be bagged within the toter. Please use discretion when putting out recyclables. Plastics will blow in the wind, and paper that gets wet in the rain is NO longer recyclable.

# ARE YOU BEHIND IN PAYING YOUR MORTGAGE, PROPERTY CHARGES, OR UTILITIES BECAUSE OF COVID-19?

#### **ELIGIBLE HOMEOWNERS**

- Must have experienced a COVID-19 pandemic related reduction in income or increase in expenses that occurred after January 21, 2020 or began prior to but continued after that date.
- Must own and occupy, as their primary residence, the New Hampshire property for which assistance is requested.
- Must have income (s) of equal to or less than 125% of Area Median Income.

**ELIGIBLE PROPERTIES:** Must be owner-occupied or in the case of a land contract or contract for deed, occupied by the documented buyer. Eligible properties include:

- · A single-family (attached or detached) properties
- Condominium units
- 1–4-unit properties where one of the units is the homeowner's primary residence
- Manufactured/modular homes permanently affixed to rest property and taxed as real estate
- Manufactured homes not permanently affixed to real property but with a Title Certificate or Statement of Ownership in the homeowner's name

# NEW HAMPSHIRE FUEL & ENERGY ASSISTANCE PROGRAM

The legislature recently approved \$25 million in State General Funds for the State Emergency Fuel Assistance Program (SEFAP) and \$10 million in General Funds for the State Supplemental Electric Benefit Programs (SSEBP). Southern New Hampshire Services, the Community Action Program administering the funding for the State program for District Three, encourages all District Three residents who believe they might be at or below 75% of State Median Income to apply - disbursements are anticipated for December.

Any residents who apply and are below the 60% State Median Income will be enrolled in the Fuel Assistance Program (FAP). Any residents who apply and are between 61% - 75% State Median Income, which does not meet the regular fuel assistance guidelines, will be in the system and ready to be enrolled in the new Emergency State Program with a benefit being paid out as early as December.

## PFAS WATER TREATMENT REBATES

The Per- and Polyfluoroalkyl Substances (PFAS) Removal Rebate Program for Private Wells is now accepting applications. The program provides rebates to private well users for up to \$5,000 for the installation of PFAS treatment or up to \$10,000 for a service connection to a public water system.

Eligible private well users must be able to document an exceedance of a regulated PFAS compound(s) with no offer of alternate water from a third party. An exceedance would be a result above New Hampshire's Ambient Groundwater Quality Standards (AGQS) for four PFAS compounds, which are: 12 parts-per-trillion (ppt) for perfluorooctanoic acid (PFOA); 15 ppt for perfluorooctane sulfonic acid (PFOS); 18 ppt for perfluorohexane sulfonic acid (PFHxS); and 11 ppt for perfluorononanoic acid (PFNA).

"New Hampshire leads the country in identifying PFAS contamination and acting on those findings," said Governor Chris Sununu. "These rebates will go a long way to help hundreds of homeowners affected by PFAS contamination to connect to clean drinking water sources or install treatment systems for their homes." NHDES has collected more than 7,200 PFAS samples from approximately 6,200 wells across the state and has identified several thousands of locations that exceed one or more of the AGQS.

While there are provisions in state rules for parties that are responsible for contamination of groundwater to remedy water supply wells that violate AGQS, not all PFAS contamination found in the state has been attributed, either technically or legally, to a responsible party. In instances where there is no identified responsible party for a contaminated water supply well, the burden of providing safe drinking water resides with the well owner. Third parties have addressed over 1,000 wells that exceed AGQS for PFAS by providing alternate water, either temporarily or permanently, in accordance with state rules. If NHDES sampled your well, an email or letter has been sent to you indicating that the program is accepting applications. If you sampled your well yourself or hired someone else to sample your well, please email pfasrebateprogram@des.nh.gov.

Eligible applicants can be reimbursed for the installation of treatment or a service connection back to September 30, 2019. "This innovative PFAS Removal Rebate program provides helpful funding for homeowners burdened with the costs of treating wells contaminated with PFAS above New Hampshire's drinking water standards," said Bob Scott, NHDES Commissioner. Funding for the program is provided by the New Hampshire Drinking Water and Groundwater Trust Fund and surplus funding from the State General Fund authorized under HB 1547. # FINANCIAL ASSISTANCE AVAILABLE FOR LOW-INCOME RESIDENTIAL WELL OWNERS IMPACTED BY DROUGHT, OTHER NATURAL DISASTERS

The New Hampshire Department of Environmental Services (NHDES) announces a new program to provide short-term relief and financial assistance for low-income residential well owners experiencing irreversible deterioration of water supply quantity or water quality caused by droughts or other types of natural disasters. The Water Assistance for Natural Disaster Impacts to Low-Income Residential Well Owners (WAND) program is funded by a \$500,000 grant from the Drinking Water and Groundwater Trust Fund (DWGTF).

In general, projects that restore the homeowner with a reliable and safe source of drinking water are eligible in this program, subject to review and approval by NHDES. This may include, if feasible, connecting the homeowner to a nearby existing community water system, rehabilitation of the well, or replacing the well. Additionally, recognizing that each well has unique water quality characteristics

and challenges, capital costs to install treatment may be included as an eligible project cost.

The WAND program may also provide immediate short-term relief with a delivery of bottled water where available or financial assistance to purchase bottled water, if requested while residents are waiting for their well improvement project to be completed. The bottled water provision will terminate upon completion of the water supply well project; if the applicant is determined to be ineligible for financial assistance; or, at the discretion of NHDES.

To prove eligibility, applicants must demonstrate their low-income status and that a drought, natural disaster or extreme weather event as determined by NHDES has adversely affected the supply or quality of water from their private well. The affected well must be associated with the eligible applicant's primary residence that they own, and the issue must be verified by a licensed New Hampshire water well contractor and/or pump installer. Low-income eligibility and the amount of financial assistance available is determined based on family size and total household income. Information on

- Operate major appliances during the cooler parts of the day. Energy is conserved by using appliances like clothes washers and dryers early in the morning or late in the evening when there is less demand on the electric system.
- Switch to ENERGY STAR® certified LED lights. The energy-efficient bulbs run cooler and last up to 25 times longer than incandescent lights.
- Set ceiling fans to rotate counterclockwise and at a higher speed in the summer to circulate the breeze more effectively, creating a cooling, wind chill effect. Remember to turn the fan off when leaving the room.
- Look for the ENERGY STAR rating when purchasing new appliances. Also, be sure to choose the right size when purchasing an air conditioning unit. An oversized or undersized AC unit is less effective and uses more energy.

#### Help is available for customers who need it:

Eversource encourages customers to enroll in one of its payment plans or assistance programs if they need help with their energy bill.
