TOWN OF FREMONT BUDGET COMMITTEE MEETINGS AND PUBLIC HEARING

The Public Budget Hearing for final review of the Town 2021 and School District 2021-2022 fiscal year budgets will take place on Wednesday January 13, 2021 at 7:00 pm at Ellis School Gymnasium, 432 Main Street. It is planned to be live broadcast and will also be rebroadcast on FCTV.

In case of inclement weather, or a need to continue the meeting, it will take place on Thursday January 14, 2021 at 7:00 pm in the same location.



WINTER PARKING BAN

The Town of Fremont Parking Ordinance: It shall be unlawful for any person to stop. stand or park a motor vehicle at any time contrary to any of the following provisions of this Section unless otherwise directed by a Police Officer.

- 1. Within the Town of Fremont, from November 15 to April 1, no parking is permitted on any public street or any town-owned right of way, or in any town-owned parking lot between 12:00 midnight to 6:00 am.
- In the event of a winter snowstorm requiring snow plowing and/or removal as deemed necessary by the Fremont Road Agent, it shall be unlawful for any person having custody and/or control of any vehicle to park or cause the same to be parked within the public right of way during a snowstorm. Vehicles interfering with snow plowing or removal operations shall be towed at the owner's expense.

NH DIVISION OF PUBLIC HEALTH SERVICES

Using Cloth Face Coverings to Help Slow the Spread of COVID-19



According to the Governor's new orders, if you need to leave your home, wear a cloth face covering. The NH Department of Health and Human Services has recommended this since the

beginning of the pandemic. This is based data about how COVID-19 can spread before a person has any symptoms. A mask helps protect others around you if you are infected and do not know it.

A cloth face covering is one more precaution we can take to help slow the spread of COVID-19 — and is not a substitute for physical distancing and other prevention measures. You still need to stay at least 6 feet away from people, even when wearing a face covering.

COVID-19 can present with a wide range of symptoms including fever, chills, cough, shortness of breath, runny nose, nasal congestion, sore throat, fatigue, headache, muscle aches, nausea, vomiting, diarrhea, or loss of taste or smell. Any person who develops new symptoms should stay home, limit their contact with others, immediately contact their healthcare provider and get tested for COVID-19. Whether or not you are experiencing symptoms, multiple testing options throughout the State are available to potentially exposed individuals. For persons without health insurance or a primary care provider, testing is available and can be scheduled by calling (603) 271-5980 or through completing the online form

at https://business.nh.gov/DOS COVID19Testing. Other options can be found here: https://www.nh.gov/covid19/resources-guidance/testing-guidance.htm.

COVID-19 continues to circulate in our communities, so all people need to protect themselves and help prevent further community spread, by:

- Wash your hands often with soap and water for at least 20 seconds or use an alcohol-based hand sanitizer that contains at least 60% alcohol if soap and water are not available.
- Avoid close contact with others. When outside your home, keep a distance of at least 6 feet between yourself and others. This is known as social distancing.
- Wear a cloth face covering that covers your mouth and nose to protect others when in public areas.
- Cover your mouth and nose with a tissue when you cough or sneeze, then throw the tissue in the trash and wash your hands.
- Do not touch your eyes, nose, or mouth with unwashed hands.
- Stay home if you have a fever or are not feeling well.
- Clean and disinfect frequently touched objects and surfaces.

MASK GIVING TREES

We have a group of mask-makers making cloth masks for any member of the community who may need one. Anyone wishing to donate masks they have made should place them in a zip-lock bag and please label each ex. adult, kids etc.; and then use the clothespins on the tree to hang them up.

The Town Hall tree on the front lawn and can be seen by walking up the ramp or the stairs. Park in the main lot. At the Safety Complex, please only use the side lot to the right, as this is an emergency building, and we prefer to keep cars out of the general flow around the building. The Giving tree is beside that side lot.

Now that winter is here we will try and keep access clear, and mask-makers are also encouraged to leave them in the mitten boxes!

ROADS & THE RIGHT-OF-WAY

Obstructions in the Town's right-of-way are not permitted. Plantings, mulch, trees, rocks, and decorative pavers ARE NOT PERMITTED. These structures of any size obstruct drainage from the roadway and cause other road problems. The high amounts of winter snow will cause added drainage and runoff issues this spring. Please help keep the ROW area clear.

RSA 236:15 states that any building, structure or fence within or over any highway is a public nuisance. Please do not place any such items in the right-of-way as they are subject to being removed by the Highway Department. In general, the Town right of way is 13 feet on either edge of the paved surface. If you have any questions, please contact Road Agent Leon Holmes Jr at 300 7430.

ABATEMENTS / EXEMPTIONS / CREDITS

If you have questions about your assessment, please feel free to contact the Selectmen's Office (Heidi, Jeanne or Kathy) by phone or email. All property assessing records are public information. You can also access the information online at the Vision Appraisal website at www.visionappraisal.com. We send updates in several times a year to the Vision site, and you can see the most recent date of updates when you log on. We are currently open by appointment only but can review information with you and send you your property record card for a more in-depth review.

If you feel that your property is disproportionately assessed, or there are listing errors on your card, you can file an abatement. Our abatement information sheet is available at the Town Offices and on the Town website at www.fremont.nh.gov. Abatement forms are available at the Selectmen's Office, or can be downloaded from the NHBTLA website at http://www.nh.gov/btla; and there is a link on the Town's website. You need Form Taxpayers 76:16 Abatement Application to Municipality. You can also call or email the Selectmen's Office and we will get one to you. Abatement forms are DUE no later than Tuesday MARCH 1, 2021 at 12 noon. A postmark of March 1, 2021 WILL also be accepted. Questions about abatements need to be directed to the Selectmen's Office, and not the Tax Collector.

Applications for new exemptions or credits will be accepted at the Selectmen's Office until Thursday April 15, 2021 at 5:00 pm. A postmark of April 15, 2021 is also acceptable. DO NOT leave your application off in the drop box after 5:00 pm on April 15, 2021 as it cannot be accepted. WEIGHT RESTRICTION ORDINANCE

After more than a year of work on an appropriate ordinance to address issues with traffic on the north side of Fremont, Selectmen adopted a Weight Restriction Ordinance. This is posted on the Town website and on the front door a.t the Town Hall as well as the Fremont Post Office. The Ordinance restricts vehicles with a GVWR of 26,000 or greater.

Signs were installed on November 25th and education will be provided by the Fremont Police Department over the coming weeks. Anyone with questions should review the Ordinance and address concerns in writing to the Board of Selectmen.

COVID MASK ORDINANCE

The Board of Selectmen have been working on adoption of a Mask Ordinance to cover use of masks within Town buildings and on Town property. This is done in conjunction with our Health Officer and Public Safety Services. The Ordinance was adopted and signed on December 17th and becomes effective January 4, 2021.

TOWN OF FREMONT Ordinance of the Selectmen

The Selectmen of Fremont, New Hampshire ordains as follows:

Emergency Mask Ordinance Related to COVID-19 Pandemic

Declaration of Purpose:

The purpose of this Emergency Ordinance is to enact public health provisions designed to significantly reduce the spread of COVID-19, a highly contagious virus that poses a dangerous health threat to citizens. These provisions, recommended by the Centers for Disease Control and the World Health Organization, and further promulgated by the Director of Public Health for the State of New Hampshire, must be implemented on a community-wide basis as part of the Town of Fremont's COVID-19 public health response plan.

Title.

This Ordinance shall be known and may be cited as the "COVID-19 Emergency Mask Ordinance of the Town of Fremont"

Authority:

NH RSA 147:1

WHEREAS, NH RSA 147:1 grants Health Officers of cities and towns the authority to draft regulations relating to the public health as in their judgement the health and safety of the people require; and

NH RSA 41:11-a

WHEREAS, NH RSA 41:11-grants the Selectmen the authority to manage all real property owned by the Town and to regulate its use unless the regulation is delegated to other public officers by vote of the Town or is governed by some other statute

WHEREAS, the Town of Fremont, New Hampshire Selectmen recognizes additional measures are necessary to prevent or reduce activities that increase the likelihood of the spread of the highly contagious and potentially life-threatening virus known as COVID-19; and

WHEREAS, the best means of slowing the spread of the virus is through minimizing close personal contact with individuals in a public environment, social/physical distancing by keeping a distance of six feet between yourself and others, covering your mouth and nose by wearing a face covering, and proper hand washing; and

WHEREAS, the Centers for Disease Control and Prevention (CDC) has concluded that the wearing of masks by all persons under certain circumstances is an effective method to reduce exposure to the COVID-19 virus, by providing a simple barrier to help prevent respiratory droplets from traveling into the air and onto other people when the person wearing the face covering coughs, sneezes, talks or raises their voice; and

WHEREAS, COVID-19 can be spread by people who do not have symptoms (asymptomatic carriers) and therefore are unaware they are infected. It is therefore important that everyone wear face coverings in public settings, whether or not they are feeling ill; and

WHEREAS, because COVID-19 presents a clear and present danger to the general Fremont population, it behooves the community for the Selectmen to take this emergency measure requiring the wearing of face coverings in certain situations to protect the public health;

NOW THEREFORE, for the purpose of continuing to provide safety for its residents and visitors acting in their capacity as the Fremont Selectmen and based on the Town Health Officer's authority to promulgate regulations for the prevention and removal of public health nuisances, hereby ordains that:

- 1. Any one entering any Town of Fremont owned facility, as allowed under Orders by the State of New Hampshire, which are open to the public, shall be required to wear a mask when entering the facility. Members of the public must wear face masks while using or working at any public recreation areas and other public property within the Town of Fremont where maintaining adequate social/physical distancing is not possible due to pedestrian congestion. Failure to wear a mask will result in the refusal of entry and service.
- All employees at any Town of Fremont owned facility except when they are working alone in a closed room, must wear a mouth and nose covering mask when interacting with the public and are within six feet of a co-worker.

- 3. All employees of the Town of Fremont when in the normal course of their employment are required to be in a vehicle with a second person shall wear a mask covering their nose and mouth
- 4. The requirement to wear a mask shall be posted on all, Town of Fremont facilities and public areas.
- 5. Under the above circumstances, this order shall apply to any individual who is over the age of five (5) years, and not otherwise exempt per CDC guidelines. A face covering is also not required to be worn by any person if said person can show a medical professional has advised that wearing a face covering may pose a risk to said person for health-related reasons.
- 6. As used herein "face covering" means a covering made of cloth, fabric, or other soft or permeable material, without holes, that covers only the nose, mouth, and surrounding areas of the lower face. A face covering may be factory made or homemade and improvised from ordinary household material.

Enforcement

- 1. For the proposes of enforcement the Selectmen may appoint persons to serve as Deputy Health Officers to serve as enforcement agents pursuant to New Hampshire RSA 147:1.
- All law enforcement officers and employees of said facilities are hereby authorized, empowered and directed to enforce compliance with this Ordinance
- 3. This order shall remain in effect until notice is given that it is no longer necessary because the State of New Hampshire and or the Fremont Health Officer declares that a Public Health Emergency no longer poses a threat to Fremont citizens.

Penalties:

Anyone who violates this ordinance AND refuses to comply with local, county, or state Health Officers to meet the requirements outlined herein shall be subject to a verbal or written request to comply by the Health Officer, followed by fine in the amount of \$100 for the second offense, \$200 for the third offense, and \$500 for the fourth and subsequent offense, for any refusal to leave a Town owned property or any public place after being given a lawful order to do so he /she will be guilty of Criminal Trespass pursuant to RSA 635:2 he/she shall be summoned to Court at the 10th Circuit — District Division - Brentwood.

Effective Date:

Having held one public hearing on December 15, 2020, this Ordinance shall be effective on January 4, 2021.

Tuesday January 12, 2021 by 12 noon – Town Petitioned Warrant Articles are due at the Selectmen's Office, Town Hall, 295 Main Street.

SAU 83 is accepting School District petition articles, contact them for time of filing. The deadline of January 12, 2021 is the same for both Town and School articles.

Any petition articles, all Town and School budgets and Warrant Articles will be discussed at the Public Budget Hearing on Wednesday January 13, 2021. The hearing begins at 7:00 pm and

will be held at the Ellis School in the Gym to allow for social distancing. The meeting will be live broadcast on FCTV Channel 22, and rebroadcast throughout the voting season, until Town Meeting Voting on Tuesday March 9, 2021. Emails will be accepted during the meeting at https://doi.org/nc.gov or texts with questions to 603 418 4416 and we will endeavor to offer a Teams/Zoom option.

Tuesday January 19, 2021 - Last day for new registrants who want to register prior to Candidate Declaration Period. Supervisors of Checklist will meet from 7:00 to 7:30 pm at the Fremont Town Hall in the basement meeting room. This is the last time to register to vote prior to the Deliberative Sessions. If you are not registered, you cannot vote at either Town or School Deliberative Sessions. No registrations can be accepted at Deliberative Session.

Please bring proper ID and proof of residency to register to vote and to all elections. The State has tightened up the forms, and if you don't have an ID with a Fremont address on it, you will need to bring documentation from form Verifiable Action of Domicile RSA 654:7V (available on the Town's website, from the Supervisors at a sign-up session or from the Town Clerk.)



NH DES DROUGHT UPDATE

According to the <u>U.S. Drought Monitor map</u> released Thursday December 17th, drought conditions have slightly expanded. Since last week, there has been minor expansion of "moderate drought"(D1) in Sullivan County. Also, "abnormally dry" conditions have slightly expanded further through Grafton County and contracted in southern Cheshire and Hillsborough Counties. There has been no change to the areas in the southeast experiencing

"severe drought" (D2). An updated U.S. Seasonal Drought outlook indicates that the "severe drought" in this area is likely to improve, but persist through the end of March, and ameliorate in all other areas of the state. According to the NH Groundwater Monitoring network, groundwater levels have stopped dropping across the State, and are in fact rising in most areas. However, all well levels remain below normal except for two, a dug well in New London and an overburden well in Barnstead, which have recovered. The snow today is predicted to fall the most right where we need it. Six to twelve inches is expected to accumulate from the southern Lakes Region south (6-12"), with even more snow to be received (10-18+") in lower Merrimack Valley from Concord south and close to the coast.

While conditions are trending in the right direction, it is advised to monitor conditions carefully and continue to promote indoor water saving tips. Also, while precipitation deficits are the greatest in the southeast, long term precipitation deficits remain throughout the entire state. As the three-month precipitation outlook indicates equal chances of above, below, and near normal precipitation, outlooks beyond three-months are not very reliable, and La Nina is likely to bring warmer temperatures; it is difficult to determine what the winter has in store for the state in terms of precipitation amounts and types.

The best way to address uncertainty is to make sure you are prepared. A multi-year drought is very possible. Drought Guidance for Municipalities and Drought Guidance for Community Water Systems is available on the <u>Drought Management webpage</u>. Community water systems should also consider conducting water audits to evaluate and address water losses, complete leak detection surveys, ensure emergency connections are operational, and assess the need for backup sources or emergency connections.

IMPORTANT! Are residential well owners experiencing well shortage issues in your community? If so, they may qualify for the Low-Income Residential Drought Assistance Program.

Drought Guidance for the public, municipalities, and private well owners, as well as other drought information such as guidance on setting up an emergency water access location may be found on the Drought Management webpage.

Drought Update:

According to the <u>U.S. Drought Monitor</u>, currently 9.66% of the state is categorized as "severe drought"(D2), 30.38% of the state is categorized as "moderate drought"(D1), 22.17% is categorized as abnormally dry, and 37.79% is not in drought.

Over the past 7-days, most of southern and central New Hampshire and the White Mountains received between 0.5" to 1.0" of rain. Further north 0.1" to 0.5" of rain was received. (National Weather Service Precipitation Observed & National Weather Service NERFC).

This week 60-day departures at the county level are below normal, except for Rockingham, Strafford and Hillsborough, which are above normal. 30-day departures are below normal for Coos, Grafton, and Sullivan and above normal for all other counties. Month to date departures are below normal for each county except Rockingham and Strafford. (National Weather Service).

New Hampshire Groundwater Level Monitoring Report for November 2020 has been released. The majority of the wells in the network are experiencing below normal to low groundwater levels, although water levels in about half of the wells in the network have risen since last month. Overburden well CVW-04 in Concord, and overburden wells in Campton, Deerfield, Franklin, and New Durham have been below normal to low for a 6-month period. The overburden wells in Newport have been below normal to low for almost a year. The bedrock wells in East Kingston and Hooksett have been below normal to low for a 6-month period. The dug well in New London and the overburden well in Barnstead have recovered to normal since last month.

Forecast and Outlooks:

Snow accumulations from southern Lakes Region south will add up to 6-12" in the majority of the area, with lower Merrimack Valley from Concord south and close to the coast receiving even more, 10-18+". From the northern Lakes Region to the southern White Mountains 3"-6" is expected and areas further north will receive 1-3". Little precipitation through early next week is expected to follow, although there may be some scattered snow and rain showers.

(WMUR & NOAA National Weather Service Forecast & NOAA Precip Forecast).

The 6-10 day outlook favors above normal precipitation and temperatures across the state. The 8-14 day outlook favors above normal precipitation and below normal temperatures. The 30-day outlook favors above normal precipitation and above normal temperatures. National Weather Service Climate Prediction Center).

According to the <u>US Monthly and Seasonal Drought Outlook</u>, over the next month drought removal is likely, except for the southeastern portion of the state where drought is likely to persist but improve. The seasonal outlook (Dec 17-March 31) predicts that drought removal is likely in all areas currently experiencing "moderate drought" (D1) and the area experience "severe drought" (D2) will remain, but improve.
