

PUBLIC HEALTH NOTICE MOSQUITO CONTROL PROGRAM WNV & EEE

Pending the Selectmen executing a contract, applications to control larval mosquitoes are planned to begin in early April 2011 in the Town of Fremont. Larval mosquitoes will be controlled in areas such as marshes, red maple swamps, woodland pools, flooded fields, roadside ditches and flooded stormwater basins. Mosquito larvae found in catch basins will also be controlled. The primary control agent will be a bacterium larvacide called Vectobac (BTI) or Vectolex (Bs). These environmentally- friendly biological controls are very specific to mosquito larvae and are used worldwide in mosquito control. The bacterium are naturally occurring and will not replicate itself in the environment. Applications to control larvae will continue as needed until November 30, 2011. Control agents will only be applied where larvae are collected.

Many mosquito breeding areas have been identified already. Please contact Municipal Pest Management Services, Inc. if you have areas of stagnant or standing water on your property that may support mosquito breeding. Areas with flowing waters (streams, rivers) or deep water (ponds and lakes) typically do not support mosquito breeding.

Persons not wishing their properties treated must contact the Board of Selectmen in writing at PO Box 120, Fremont, NH 03044-0120 or by e-mail at Selectmen@Fremont.nh.gov. Letters can also be dropped off at the Selectmen's Office at 295 Main Street. Information on biological control agents, insecticides, areas likely to be treated or any potential hazards is available upon request to Municipal Pest Management Services, Inc at 603 431 0008 or by email to swampfixer@myfairpoint.net.

DOG LICENSES FOR 2011

Dog License Reminder: The 2011 dog license tags are available. A current rabies certificate is required for licensing your dog(s) as the Clerk's office is required by law to retain a copy of the vaccination certificate. You may call the office to inquire if the rabies certificate on file is still valid. Please be sure to license your dog(s) by April 30th to prevent the initiation of a late penalty of \$1.00 per month. As required by RSA 466:1, all dogs must be licensed each year by April 30th. For your convenience, the license(s) can be mailed for an additional fee of \$1.00 per license or you can also license your dog(s) online by going to the Town Clerks page on the Town's website at Fremont.nh.gov and click E-Dog. If you no longer have your dog, we ask that you please contact the Clerks office at 895-8693 so we can update our records accordingly.

ANOTHER OPPORTUNITY TO GET YOUR DOG LICENSED

The Town Clerk will be available to issue dog licenses at the rabies clinic being held on April 16, 2011 at the Fremont Safety Complex from 9:00 am to 1:00 pm. Even if your dog does not need a vaccination you may stop by and obtain a license. The rabies vaccination records for all dogs previously licensed in Fremont will be available.

FREMONT ENERGY COMMITTEE: STATUS REPORT

Starting in 2007, the Energy Committee, in conjunction with the Board of Selectmen, Town Administrator, Building Inspector/Code Enforcement Officer, Fire Department, Police Department, Town Employees, Fremont Public Library and Ellis School has initiated a wide range of programs and projects to reduce energy use in Fremont. The primary goals are to minimize the use of fossil fuels and the resultant greenhouse gas emissions, minimize present and future energy costs(Tax \$) and to provide an information format for Fremont residents, including the Student Body.

Initially, the efforts have focused on municipal buildings and activities. Significant progress continues to be made, primarily due to un-failing support and co-operation of the previously mentioned individuals and departments in our town. If no energy efficiency measures were taken, the ten year projection for Fremont's municipal energy costs would likely be in the \$3 million range, or more. If conservation and efficiency efforts, combined with utilization of alternative energy technology are implemented, greenhouse gas emissions and tax \$ expenditures will be substantially reduced. Each 10% reduction will save \$300,000!

The projects which have been initiated have been entirely funded by grants provided by public, private and non-profit entities. Fremont benefits from the savings on energy costs, with no negative impact on tax bills. The following organizations have provided grants to Fremont: Municipal Energy Assistance Program(MEAP); Regional Greenhouse Gas Initiative(RGGI); Wal-Mart; PSNH; AARA(Federal Stimulus Block Grant); Clean Air/Cool Planet).

Fremont ENERGY Projects & Programs:

- Publication in the NEWSLETTER and Town Web-Site of energy related tax incentives and energy conservation suggestions. (On-going)
- Installation of energy efficient lighting in Town buildings. (Completed)
- Fuel use reduction programs in Town Departments. (On-going.)
- Building energy audits at the Ellis School, Town Hall and Safety Complex. These in-depth audits will give a detailed roadmap to energy conservation and utilization of energy efficient technology to power our buildings and activities. (Audits completed.)
- Installation of photo-voltaic solar panels on Safety Complex. A visual demonstration of Fremont's commitment to energy conservation as well as an educational tool. Performance can be monitored town web-site. (Initial installation complete.)
- Improved insulation installed at the Safety Complex. (Completed.)
- Solar hot water system at the Safety Complex. (Funded; awaiting bid submission.)
- Geothermal heating/cooling system at the Town Hall. (Under consideration; seeking funding sources.)

The challenge for the future is to continue municipal energy reduction programs at a minimum cost and maximum payback; expand energy-related education efforts aimed at Fremont residents with a focus on the student body and develop meaningful volunteer efforts to reduce energy usage by Fremont residents. A recent study estimated that NH residents spent over \$6,000 per person on energy related activities, direct and indirect. This figure will rise as energy costs increase, as they will, if meaningful efforts are not made.

Fremont residents have a host of abilities and ideas to offer. The Energy Committee would welcome your participation at any level of commitment in time or effort. Please volunteer to help advance these interesting and necessary programs!!

Budget Committee Clerk: The Town of Fremont is seeking qualified applicants for a part-time, stipend clerical position to serve the Budget Committee. Position requires attendance at evening meetings (14 – 16 annually, busiest during the months of September through January); interaction with the public and Board members, taking and preparing minutes. Recordkeeping, organizational, computer, and written skills a must. Municipal experience preferred, but will train. Position could include other board meetings as needed.

Cemetery Laborer: The Town of Fremont is seeking applicants for a part-time, seasonal labor position within the Town's cemeteries. Suitable candidate should be a self-starter and able to work with minimal supervisions, primarily responsible for lawn care and mowing, trimming, leaf raking, and general cemetery maintenance. FREMONT ENERGY COMMITTEE PUBLIC PRESENTATION BUILDING ENERGY AUDIT REPORTS

The Fremont Energy Committee, with Town and School representatives and GDS Associates Inc Engineers & Consultants, will hold a public session to review the findings and Energy Audit results. The meeting will begin at 6:00 pm at the Ellis School Library located at 432 Main Street in Fremont. The Ellis School Building portion will begin at 6:00 pm; followed by the review of the Safety Complex.

The energy audits were funded by a NH Energy Efficiency and Conservation Block Grant awarded to the Town in 2010.

The nearly 100 page report will be available for viewing on line in PDF format as well as at the buildings for review by the public.

CHECK YOUR SMOKE DETECTORS

The weekend of March 12 and 13, we all set our clocks to Daylight Saving Time. The time change is a good reminder to check your smoke alarms and CO detectors. According to the National Fire Protection Association (NFPA), more than 66 percent of home fire deaths that occurred between 2003-2006 were in homes without a working smoke alarm. A working smoke alarm significantly increases your chances of surviving a deadly home fire.

A properly installed and maintained smoke alarm is the only thing in your home that can alert you and your family to a fire 24 hours a day, seven days a week. Whether you're awake or asleep, a working smoke alarm is constantly on alert, scanning the air for fire and smoke. Smoke alarms must be maintained! A smoke alarm with a dead or missing battery is the same as having no smoke alarm at all, so test your smoke alarm monthly by pushing the "test" button, if it has one.

Smoke alarms are powered by either a battery or are hardwired into your home's electrical system. Hardwired smoke alarms are usually equipped with a backup battery. If your smoke alarm is powered by battery, the battery needs to be replaced at least annually unless it is a long-life battery (check the owner's manual). All batteries should be maintained and replaced in accordance with manufacturer's guidance. Choose an annual date, such as the time change twice per year, when you will remember to maintain your smoke alarms and CO detectors in tip top condition.

Check the manufacturer's expiration date on the label, replace the batteries if needed, and clean dust away from the slots so that smoke can enter freely. All smoke alarms, hard-wired and battery powered, should be replaced at least every five to seven years. These simple steps will help ensure that you and your family will have the best chance of surviving if fire should strike.

USFA has a fire safety campaign called Install. Inspect. Protect. which provides information about home smoke alarms and fire sprinklers. Please visit the campaign Web site at www.usfa.dhs.gov/campaigns/smokealarms/.

EMERGENCY PREPAREDNESS CLASS

This comprehensive preparedness training, developed by FEMA and used in all 50 States, helps residents take care of themselves, their families and neighbors during an emergency. Topics include: Disaster Preparedness, Fire Safety, Disaster Psychology, Safety Strategies involved in a Terror Attack, Light Search and Rescue, Incident Command Systems, CPR and First Aid. Those who complete the course will receive a Certificate of Completion from the NH Fire Academy, and CPR and First Aid certification from the American Heart Association.

This class completes the core training requirements for the Strafford County Citizen Corps (SCCC), a team of medical and non-medical volunteers who train to support and assist local first responders during emergencies. No commitment to the SCCC is required from those who enroll in the class.

Following the completion of Community Emergency Response, participants can continue to attend trainings through the SCCC (such as Traffic Control, Search & Rescue, Basic Disaster Life Support, Fire Rehabilitation, etc.), which are offered every other month.

Classes will meet Mondays, April 4 through 18, and May 2 and May 9 from 6:30 to 8:30 pm and Saturday, May 14 from 8:30 am to 3:30 pm at the Fremont Safety Complex, 425 Main Street in Fremont.

TAX INFORMATION

Tax bills will be coming out at the end of May for the first issue of 2011. If you have any questions about making a tax payment or interest calculations on a past due amount, please feel free to call 895-3200 x14, or email freemonttax@comcast.net.

If you are dissatisfied with your 2011 assessment (as of April 1, 2011), you need to wait for the issuance of the final bill of the year in December 2011, to file an abatement. Forms will be available in the fall for that purpose from the Selectmen's Office and on the Town Website.

EXEMPTION AND CREDIT APPLICATION FILING DEADLINE

The deadline to file a credit or exemption application form for the next tax year is April 15, 2011. These applications are also available in the Selectmen's Office or on the Town website at www.Fremont.nh.gov on the Board of Selectmen page. Please be sure you have all of the required documentation submitted with your application form.

The Selectmen's Office is open 8:00 am to 12 noon on Friday April 15, 2011. Applications left in the drop box after the close of business will not be accepted as timely. You can mail your application as we can accept a postmark of April 15th.

FROM THE FREMONT POLICE DEPARTMENT – FACTS ABOUT RESIDENTIAL BURGLARY

Now that vacation time is here – THE FACTS ABOUT RESIDENTIAL BURGLARY. More than six million residential burglaries occur every year in this country. That's one every ten seconds!

Nearly half of these burglaries are committed without force – that is, through UNLOCKED doors and windows! Always lock your doors and windows, even when leaving for "just a minute." NEVER LEAVE A HOUSE KEY AVAILABLE under a doormat, in a flower pot, or on the ledge of the door. THESE ARE THE FIRST PLACES A BURGLAR WILL LOOK! A large portion of our burglaries occur with the suspects walking into your homes and garages through wide open doors, particularly garage doors in broad daylight! Exterior doors should have deadbolt locks. Sliding doors and windows should have ventilation locks as well as auxiliary locks. Be sure to include good locks for garage, patio or other doors that lead out through storage areas or a spare room.

GOING OUT? Lock all doors and windows. Use timers so that lights, radio and TV go on and off throughout the house to indicate someone is home. For longer trips, be sure to stop mail and newspaper delivery or have a neighbor collect them daily. IN SHORT – MAKE YOUR HOME LOOK LIVED IN. Remember, if you come home and see a broken window or a jimmied door, don't go in. Confronting a burglar can be dangerous. PHONE THE POLICE IMMEDIATELY.

DON'T LET 'EM KNOCK YOUR BLOCK OFF! Want to know the best crime prevention device ever invented? A GOOD NEIGHBOR! Law enforcement officers can't be everywhere at once, but you and your neighbors can. You're the ones who really know what's going on in the neighborhood. Put that neighborhood know-how to work. It's simple: just use your eyes and ears – then your telephone. If you spot something suspicious, call the police immediately. Neighbors working together in cooperation with law enforcement make the best crime fighting team around.

WHAT TO DO WHEN GOING ON VACATION: Get to know your neighbors and neighborhood. Share daily schedules, and keep an eye on each other's property. Leave shades and blinds in their normal positions. Put two or three lights and a radio or TV set on a timer. Inexpensive plug-in timers are available at most hardware stores. Inform a trusted neighbor of your travel plans. If you plan to be away for more than a day or two, ask them to collect mail and other deliveries. Arrange to have your lawn mowed. CAMP COUNSELOR APPLICATIONS BEING ACCEPTED FOR CAMP FREMONT

Camp counselor applications are being accepted for Camp Fremont! Applicants must be dependable, adaptable, creative, and enjoy working with children; have good communication and problem

solving skills, and be a positive role model for campers. All applicants must be certified in Child CPR and preferably certified in First Aid. Prior experience working with children is required.

Applicants must possess specialized skills in the following areas: special events, arts and crafts, sports, games, management of group activities, as well as, ability to connect individually with campers, behavior management, and daily event planning and implementation. Applicants will be required to pass a Criminal Background Check.

Responsibilities Include: Work under the supervision of the Summer Camp Director and the Parks and Recreation Commission, Identify and meet camper needs, supervise campers at all times, ensuring safety and preventing accidents; adhere to the guidelines outlined in the Camp Manual; plan and implement daily camp activities according to the expectations set forth by the Camp Director; maintain, organize, and clean camp facilities, supplies, and equipment; perform various administrative tasks including signing in and out campers, providing before and after care, completing incident and accident forms, maintaining positive public relations with parents, and other assorted duties; carry out departmental discipline procedures, ensuring that all campers are held to high behavioral expectations; supervise and mentor Counselor in Training (CIT) participants.

Positions are appointed by the Board of Selectmen upon recommendation of the Parks & Recreation Commission.

FROM THE PLANNING BOARD

What is SITE PLAN REVIEW?

The Fremont Site Plan Review Regulations were adopted by the Town on October 4, 1989 as per RSA 675:6. These regulations have been amended as necessary due to growth and changes of the Town.

Site Plan Review is the process which the Planning Board determines the base and scope of any non-residential use of property. The purpose is to provide for the safe and attractive development or change or expansion of use of the site and guard against such conditions as would involve danger or injury to health, safety or prosperity due to inadequate protection. It involves making application using the Site Plan Review

Regulations and a Public Hearing. The fee is \$350.00, there is a \$150.00 cost for advertising and \$11.54 per abutter to cover the cost of certified mailings.

Who needs to apply for Site Plan Review? Anyone within the Town proposing a non-residential use of property is required to apply for Site Plan Review.

The regulations read as follows:

The Planning Board shall require site plans to be submitted to it for review by any applicant seeking any of the following:

- **A.** The development and/or construction of any non-residential use and/or venture with a commercial purpose.
- **B.** The conversion (change) or enlargement (expansion) of use of any existing non-residential use.
- **C.** The change within a structure from one permitted use to another permitted non-residential use.
- D. All multi-family dwelling units, which are designed as any structures containing more than two (2) dwelling units, whether or not such development includes a subdivision or re-subdivision of the site shall require review and approval for site plan for the development or change or expansion of use of tracts by the Planning Board.

There are separate and specific Site Plan Review Regulations for the Fremont Village District.

FROM THE PLANNING BOARD HOME OCCUPATION PERMITS

Home Occupation permit applications are filed with the Land Use Office and can be obtained either on the Planning Board page of the Town of Fremont website or at the Land Use Office or Code Enforcement Office.

Purpose: The standards of this Section dealing with home occupations are designed to protect and maintain the residential character of Fremont while permitting certain limited commercial activities which are traditionally carried out in a home. Home occupations that meet all the requirements of this ordinance are exempt from site plan review.

Definition: Home occupation is defined as any business, occupation or activity conducted for gain within a residential building, or an accessory building thereto, which is incidental or secondary to the use of such building for dwelling purposes and which does not change the essential residential character of the building. This regulation applies to all zoning districts.

The business permitted must stay within the guidelines of the Home Occupation Ordinance in order for this permit to be valid. A Home Occupation Permit is issued to the applicant only and is not transferable to subsequent inhabitants or owners of the property.

Standards:

- a. The home occupation shall be conducted solely by the member(s) of the immediate family that reside(s) in the dwelling unit except that one (1) additional non-resident may also be employed.
- b. No display, other than a name plate not more than one (1) square foot in area, that will indicate from the exterior that the building is being utilized in part for any purpose other than that of a dwelling shall be allowed.
- c. No equipment or process shall be used in a home occupation which creates noise, vibration, glare, fumes, odors or electrical interference detectible to normal senses off the lot if the occupation is conducted in a single family or accessory building; or outside the dwelling unit or accessory building if the occupation is conducted on a lot containing a duplex or multi family unit.
- All home occupations shall be conducted entirely within an enclosed building. No materials or equipment associated with the home occupation shall be stored outside the building.
- The following businesses, occupations or activities are specifically prohibited:
 - Motor vehicle and accessory sales or rental, repair and/or painting, including trailer rental or sales.
 - 2) Medical or dental clinic.
 - 3) Restaurant.
 - 4) Kennel and veterinary clinic.
 - 5) Funeral home.
 - 6) Nursery school, but not family day care, with six or fewer children.
 - 7) Repair shops or service establishments, except the repairs of electrical appliances, typewriters, cameras, or other similar small items.
 - 8) Beauty shops and barber shops, except when customer visits are by appointment only are limited to no more than two customers in any one hour period. Beauty shops and barber shops allowed under these provisions shall be registered with the appropriate licensing and inspection authorities.
- f. The home occupation shall not require the regular need for delivery of materials to and from the premises by commercial vehicles over twelve thousand (12,000) lbs GVWR. The intent is to permit delivery vehicles such as United Parcel Service vehicles but to exclude tractor-trailers and other large, heavy commercial vehicles.
- g. The home occupation should not require the need for the on-

site, over-night parking of commercial vehicles. If on-site parking of commercial vehicles, with three (3) axles or more, is necessary it shall be garaged or screened.

VITAL RECORD REQUESTS AVAILABLE ON LINE

Requests for Certified Copies of Vital Records are now available on-line. This new program works the same way as E-Reg and E-Dog. This new service is available on the Town Clerk's page of the Town's website at www.fremont.nh.gov.

TIMBER HARVESTING & INTENT TO CUT REPORTING

Any landowner who filed an Intent to Cut for the 2010 tax year must file the Report of Wood Cut in the Selectmen's Office no later than April 15, 2011. If you are missing your Report forms, contact the NH Department of Revenue Administration at 271-2687 to request them.

Reports not filed in a timely fashion are subject to fines or penalties. There is additional information on the Town's website at www.Fremont.nh.gov on the Board of Selectmen page regarding timber harvesting and the NH Forestry Laws.

If you are planning a timber harvest, Intent to Cut forms are available in the Selectmen's Office during normal business hours.
