# TAX CREDIT & EXEMPTION APPLICATIONS

Forms will not be accepted if dropped off after 4:00 pm on April 15th but an April 15, 2014 postmark is acceptable. ### RABIES CLINIC

### **GET YOUR DOG LICENSED BY APRIL 30**

2014 dog licenses are available. A current rabies certificate is required for licensing your dog(s) as the Clerk's Office is required by law to retain a copy of the vaccination certificate. Please call the office to inquire if the rabies certificate on file is still valid. You must license your dog(s) by April 30<sup>th</sup> to prevent the initiation of a late penalty of \$1.00 per month. As required by RSA 466:1, all dogs must be licensed each year by April 30<sup>th</sup>. For your convenience, the license(s) can be mailed for an additional fee of \$1.00 per license, or you can license your dog(s) online by going to the Town Clerk page on the Town's website at <a href="www.Fremont.nh.gov">www.Fremont.nh.gov</a> and click E-Dog. If you no longer have your dog, please contact the Clerk's office at 895 8693 so we can update our records accordingly.

# DEPUTY TOWN CLERK/TAX COLLECTOR POSITION OPENING

Fremont by the way, proudly sent 99 soldiers into the Civil War (1861 to 1865) of which 22 died. Not one native Fremonter ever deserted during the Civil War! The last surviving Fremont Civil War soldier was Samuel J. Willey (who lived on the north side of town) and died on July 17, 1927.

# SUMMER CAMP PROGRAM DIRECTOR & ASSISTANT DIRECTOR POSITION OPENINGS

The Town of Fremont is accepting applications for a Summer Camp Director and Assistant Director for our Camp Fremont Summer Recreation Program. Camp Fremont runs for six weeks from July 7 to August 15, 2014, daily from 9:00 am to 3:00 pm with some extended care available.

Duties include: research, scheduling and conducting field trips, bus rentals, and guest-speakers; establish curriculum and activities; effective parental communication through greeting parents, dealing with parental concerns, writing newsletters, overseeing payroll and budgeted expenses, and review of all A/P related to the program; maintain inventory and purchase supplies; act as a leader and mentor to counselors, providing them with guidance and opportunities to grow; manage disciplinary issues; evaluate camp and staff; advertise and conduct an informational night; and compile program reports as needed.

Positions require a background in Education, preferably Physical Education/Recreation, or previous experience as a Camp Director, Assistant Director, or Lead Counselor. Salary commensurate with experience. Interviews will begin as soon as possible.

## REQUEST FOR PROPOSALS REPAIR TOWN HALL FRONT STEPS

The Town of Fremont is seeking qualified contractors interested repairing the front steps at the Town Hall, located at 295 Main Street in Fremont NH. The building houses the Offices of Selectmen, Town Clerk Tax Collector, Planning, Zoning & Building Services.

Currently there are 7 steps and a landing with metal plating that is lifting due to wear and frost. Wood underneath will need to be inspected and repaired or replaced. Metal non-skid stairs may be reinstalled if considered to be safe and in good condition. If not, a similar non-skid surface will need to be installed. Bidder needs to recommend best solution to make these steps safe for public use and inspect current handrails for safety. Stairs and handrails must meet current code requirements. Contractor should make a recommendation on all needed improvements, repairs and upgrades.

Repairs need to be scheduled when offices are not open if possible, or scheduled such as to coordinate with use of the front ramp (in good weather), with applicable safety barricades and signage installed so as to allow for public access during business hours. Cleanup and removal of all debris shall be done by successful bidder.

The Selectmen's Office is open daily Monday & Friday 8:00 to noon, Tuesday & Wednesday 8:00 am to 4:00 pm and Thursday from 1I:00 am to 5:00 pm. The area outside the building can be viewed at any time. Questions can be directed to Town Administrator Heidi Carlson in the Selectmen's Office at 895 2226 x 10 or Building Inspector Bob Meade at 895 3200 x 18. All code questions shall be directed to the Building Inspector.

Please submit proposals marked "Town Hall Front Steps" to Board of Selectmen, PO Box 120, Fremont NH 03044-0120 if submitted by mail. Proposals can also be hand-delivered to the Selectmen's Office at 295 Main Street in Fremont. Please include at least three references for whom similar work has been performed. All proposals shall be received not later than April 16, 2014 by 4:00 pm at the Selectmen's Office.

The Town reserves the right to accept or reject any/all bids deemed to be in the best interest of the Town of Fremont.

The successful Contractor will be required to provide full insurance documentation, including General Liability coverage of not less than \$1,000,000 and Workers Compensation as required by NH Statute; with certificates naming the Town of Fremont as an additional insured.

Bids will be opened and tabulated following the submission deadline, for final information to be presented to the Board of Selectmen at their regularly scheduled meeting as soon as possible.

After the bid opening, the Bidder may not amend, correct, modify or change in any fashion, a bid, which would be contradictory to the interests of the Town of Fremont or to fair competition. The Board of Selectmen may waive minor informalities, or allow the bidder to make corrections, as long as the intent of the bid is not disturbed.

The Town of Fremont reserves the right to request additional data or information or a presentation in support of written proposals. However, the Town may award a contract based on offers received, without additional submissions. Accordingly, the proposal should be submitted on the most favorable terms from all aspects, which the Bidder can submit. The Town reserves all rights to negotiate with the contractor of its choice based not solely upon cost alone, but on the qualifications and ability of the consultant to perform, consistent with the Town's intent, requirements, time schedule, and funds availability.

The following non-collusion clause shall be part of every bid specification package. Bidders must sign this statement in order for the bid to be valid:

"The undersigned certified under penalties of perjury that this bid is in all respects bona fide, fair and made without collusion or fraud with any other person. As use in this section the word "person" means any natural person, joint venture, partnership, corporation or other business or legal entity."

# MORE TOWN CLERK UPDATES OFFICE HOURS

### **VEHICLE REGISTRATION RENEWALS**

When renewing your vehicle registration or boat registration in person, you **MUST** provide the Clerk's office with the current registration or the "courtesy" renewal notice that you received in the mail. This is a State law.

#### ID FOR VEHICLE REGISTRATIONS

When registering a vehicle with the Town Clerk's office you MUST present a valid photo id or driver's license in order for your transaction to be completed. This requirement has been issued by the NH Department of Safety – Fraud Unit.

### **NEW VEHICLE REGISTRATIONS**

When registering a vehicle that is less than 15 years old, you must provide either of the following: the title, signed by the previous owner or the title application that the dealer gave you. If you have the title, all owners MUST be present when registering, with their valid ID, to sign the title application. If you have the title application, anyone can register your vehicle for you, on your behalf, however they must present their ID.

### TRANSFER OF PLATES

If you are transferring plates from your old vehicle to another one you MUST turn in the current registration for the old vehicle. This has to be sent to the state with the transfer documentation. Failure to have this document in hand will require you to purchase a duplicate at a cost of \$18.00.

Please note: PLATES CAN ONLY BE TRANSFERRED FROM ONE VEHICLE TO ANOTHER IF THE PRIMARY OWNER REMAINS THE SAME.

## MOTOR VEHICLE REGISTRATION RENEWAL & DOG LICENSING RENEWAL AVAILABLE ON-LINE!





Internet transactions will be accepted through a kiosk to <u>renew</u> your motor vehicle registrations and <u>renew</u> your dog licenses from your computer at home. Customers will be directed to a secure web site through the kiosk. The Town of Fremont will receive all applicable fees and there is no charge to the Town for the electronic payment. Customers are charged a convenience fee for the transaction.

All inquiries are directed through our software provider's website and there is no direct access to the Town's computers or their systems.
