2018 TOWN MEETING VOTING **RESULTS**

Pursuant to NH RSA 40:13 II, the first session of the 2018 Town Meeting (the Deliberative Session) was held on Monday February 5. 2018 at the Ellis School at 432 Main Street in Fremont NH at 7:00 pm.

The second session (voting session) was held on Tuesday March 13, 2018 at the Ellis School at 432 Main Street in Fremont NH with polls open from 7:00 am to 8:00 pm. All articles were voted upon by official ballot, and there were no amendments made at the Deliberative Session. A total of 594 ballots were cast, 543 regular and 51 absentee. Nineteen (19) new voters were registered on Election Dav.

ARTICLE 2: Are you in favor of the proposed amendment to Article VII Section 707 of the Fremont Zoning Ordinance (Table of Uses) so that "light manufacturing" is a permitted use in the Corporate Commercial District and in the Commercial Highway District? This article would also allow "Light Manufacturing" in the Flexible Use Residential District after obtaining a Conditional Use Permit from the Planning Board. Finally, this article will amend the Zoning Ordinance by defining "light manufacturing." The Planning Board recommends this article (majority vote required).

ARTICLE 3: Are you in favor of the proposed amendment to Article X Section 1002 of the Fremont Zoning Ordinance (Village District Ordinance) so that the amount of square footage permitted for a retail shop in the Village District will be increased from 7,000 to 10,000 square feet? This article will also amend the Fremont Zoning Ordinance by allowing "light manufacturing" in the Village District provided that there is no outside material storage associated with the business. The Planning Board recommends this article (majority vote required).

ARTICLE 4: Are you in favor of the proposed amendment to Article XII Section 1202 of the Fremont Zoning Ordinance so that the Floodplain Development Ordinance complies with the National Flood Insurance Program? The Planning Board recommends this article (majority vote required).

ARTICLE 5: Are you in favor of the proposed amendment to Article XIII Section 1301.2 of the Fremont Zoning Ordinance by changing the limit of total number of elderly housing units permitted so that it does not exceed fifteen (15) percent of the total dwelling units in the Town of Fremont? This article will also amend the Zoning Ordinance so that determining the total number of dwelling units in the Town of Fremont (for the purpose of calculating the permitted amount of elderly housing units) is based on the NH Office of Strategic Initiatives (OSI) most recent estimates. The Planning Board recommends this article (majority vote required).

ARTICLE 6: Are you in favor of the proposed amendment to Article XI Section 1101 of the Fremont Zoning Ordinance (Accessory Dwelling Units) submitted by petition so that an accessory dwelling unit is permitted without a Special Exception from the Zoning Board of Adjustment? This article will also amend the Zoning Ordinance so that detached accessory dwelling units are prohibited except if the structure has had an occupancy permit for more than five (5) years or was built before January 2010. This article will also amend the Zoning Ordinance so that the living area of an accessory dwelling unit can be a maximum of one half the primary living unit or eight hundred (800) square feet, whichever is greater. This article will also amend the Zoning Ordinance so that there is no longer a limit of two bedrooms in an accessory dwelling unit. Finally, this article will amend the Zoning Ordinance so that the language, "Variances to this special exception may not be granted" is no longer in the Ordinance. The Planning Board's motion to recommend this Ordinance change did not pass. The final vote was 2-3 (Majority vote required).

Note: This operating budget warrant article does not include appropriations contained in ANY other warrant articles. The Selectmen recommend this appropriation 3-0. The NH Primary will be held on Tuesday September 11, 2018 at Ellis School. Polls are open for all elections from 7:00 am to 8:00 pm. Due it being a PRIMARY there is a VERY EARLY deadline to change your party affiliation. You must change you party affiliation no later than June 5, 2018. Whatever party you are registered at that time is the ballot you will be given at the September Primary. New registrants can declare when they register, but if you are already registered, you cannot change your party affiliation after June 5, 2018.

The November General Election has all candidates on one ballot so you do not have to choose a party.

The Supervisors of the Checklist will be in session on Tuesday June 5th at the Fremont Public Library from 7:00 to 7:30 pm for this purpose, and you can change your party affiliation with the Town Clerk or during any posted session of the Checklist Supervisors. The Supervisors generally meet the first Tuesday of each month from 7:00 to 7:30 pm at the Fremont Public Library.

POLITICAL ADVERTISING SIGNS

NH RSA 664:17 Placement and Removal of Political Advertising:

"No political advertising shall be placed on or affixed to any public property including highway rights-of-way or private property without the owner's consent. The candidate shall remove all political advertising no later than the second Friday following the election unless the election is a primary and the advertising concerns a candidate who is a winner in the primary. Signs shall not be placed on or affixed to utility poles or highway signs. Political advertising may be placed within State-owned rights-of-way as long as the advertising does not obstruct the safe flow of traffic and the advertising is placed with the consent of the owner of the land over which the right-of-way passes.

No person shall remove, deface, or knowingly destroy any political advertising which is placed on or affixed to public property or any private property except the owner of the property, persons authorized by the owner of the property, or a law enforcement officer removing improper advertising. State, City, or Town Maintenance or Law Enforcement Personnel may remove political advertising placed on or affixed to any public property. Political advertising removed prior to election day by state, city, or town maintenance or law enforcement personnel shall be kept for one week at a place designated by the state, city, or town so that the candidate may retrieve the items.

As it pertains to the highway right-of- way provision, the Fremont Board of Selectmen, after consultation with the Fremont Town Clerk and Moderator, has outlined the following guidelines:

- No political signs shall be placed on Town Property outside of the road right-of- way.
- Within the road right-of-way [generally 13 feet from the edge of pavement or travel way], signs may only be placed with the direct abutter's permission. This refers to the abutter on that side of the street.
- 3. At the polling entrance, unattended political signs may be placed only on the actual polling day during open polling hours [7:00 am to 8:00 pm]; and only in the designated area as determined by the Moderator. The designated area will be appropriately marked and placed in an area that will not obstruct or hinder the safe flow of traffic. (This designated area allows the Town of Fremont to abide by the Attorney General's rules). Signs shall be removed immediately following the election.
- A candidate or the candidate's representative must attend all other signs which will be permitted in an area designated by the Moderator in accordance with RSA 659:43.

The Town of Fremont designates the Fremont Safety Complex as the storage location for any political advertising signs removed for improper placement; or those found after having been displaced by wind or weather conditions. RECYCLING TOTERS

Residents have asked about using a toter-type unit that you can buy at home or hardware stores, to keep their recycling in. Waste Management has always indicated you can use an alternative recycling container, but they cannot accept any responsibility for these units. If you choose to buy a toter that has a pickup hinge on it, they may be able to pick it up with the hydraulic arm, but they are not of the same heavy grade construction as our trash toters and are prone to breakage. WM will not be responsible for any breakage of these personal units. They cannot be any heavier than 50 pounds.

WASTE MANAGEMENT TOTERS

Waste Management has notified us that they are tagging broken toters for replacement. They have also brought to our attention that some single-family homes have two toters out for pick up each week. They are calling our office to check if they are a legal two family or in-law. If our records show they are not, then they will be taking the second toter away. Per our contract with Waste Management each single-family home is only allowed one toter. Your cooperation is appreciated in this matter.



WASTE MANAGEMENT RECYCLING

Recently Waste Management has reached out to let the Town know of some changes that have been made regarding the items we recycle. When we export the recycled items, there is a stricter quality control needed and Waste Management will be checking the quality of items sent. Recently we

were given a new Acceptable Materials List, simply stated they accept Plastic Bottles and Containers, Tin and Aluminum Cans, Beverage Cartons, Paper, Cardboard and Glass Bottles. Nothing else should go in the recycling bin, especially plastic bags, even if they have the recycling emblem on them.

WATER TESTING IN FREMONT

NH DES MtBE Remediation Bureau Information

The New Hampshire Department of Environmental Services MtBE Remediation Bureau recently mailed letters to some Fremont residents. These properties were identified as being served by private wells and located in an area that is *potentially* vulnerable to gasoline contamination. Additional letters will be mailed out in a few weeks.

For a limited time, the NHDES MtBE Remediation Bureau is extending this invitation to all Fremont residents that have a private well. This work will



be performed at no cost. Due to settlement fund restrictions NHDES can only pay for a MtBE-related (VOC) analysis, which also includes other common gasoline and chemical contaminates. If you elect to have additional analyses added, you will need to pay for those analyses.

If you did not receive a letter from NHDES you may still request to have your well tested, please contact Sarah Bartlett at (603) 271-0544 or sent an email to Sarah.Bartlett@des.nh.gov to set up an appointment.

Additional testing of private wells is recommended every 3-5 years to understand common problems with drinking water quality.

CYCLICAL ASSESSING UPDATES

The Town's new assessing contract includes cyclical updates. This means that 1/4 of the Town will be reviewed each year (data and listing information) toward the end goal of the every fifth year revaluation/recertification process required by the State. Assessors will be out in the field more often looking at all the housing stock. They will update photos and listing information and will ask to view your home if you are there when they visit. This is at the owner's discretion but is most helpful to the Town to ensure we have the best, most up to date information to arrive at your assessed valuation.

MRI personnel are in the field working on these properties, and they carry MRI Photo Identification and have with them, a letter from the Town (signed by the Town) with their name and vehicle information including license plate number. Currently Dan Scalzo and Bill Cafarelli are primarily working in Fremont collecting the data. The Selectmen's Office will always know when they are working in Fremont, so please feel free to call us if you have any questions. SUMMER CAMP PROGRAM DIRECTOR
