# NH LOW & MODERATE INCOME TAX RELIEF

This fee covers application and inspection as related to the Town's newly adopted Sign Ordinance, part of the Fremont Zoning Ordinance. Any additional inspections (if more than one) are charged at a \$25 fee per.

### FOOD VENDOR PERMIT

\$25.00

This fee covers application and inspection as related to the requirement for food service vendor inspections at events. Any additional inspections (if more than one) are charged at a \$25 fee per.

### RECYCLING TOTERS

Residents have asked about using a toter-type unit that you can buy at home or hardware stores, to keep their recycling in. Waste Management has always indicated you can use an alternative recycling container, but they cannot accept any responsibility for these units. If you choose to buy a toter that has a pickup hinge on it, they may be able to pick it up with the hydraulic arm, but they are not of the same heavy grade construction as our trash toters and are prone to breakage. WM will not be responsible for any breakage of these personal units. They cannot be any heavier than 50 pounds.

We love to see you recycle more as it saves the Town money, so thank you for your efforts!

### **WASTE MANAGEMENT RECYCLING**

Recently Waste Management has reached out to let the Town know of some changes that have been made regarding the items we recycle. When we export the recycled items, there is a stricter quality control needed and Waste Management will be checking the

quality of items sent. Recently we were given a new Acceptable Materials List, simply stated they accept Plastic Bottles and Containers, Tin and Aluminum Cans, Beverage Cartons, Paper, Cardboard and Glass Bottles.

Nothing else should go in the recycling bin, especially plastic bags, even if they have the recycling emblem on them. We also recently learned that flower pots, and the plastic "six pack" that annual flower come in, are also NOT recyclable even if they show the recycling symbol. This has to do with size and processing limitations. so

The guidelines are available at the Town Hall and on the Town's website. If you have any questions, please check the Town web site or call the Selectmen's Office at 895 2226 2226 x 303 (Jeanne) or x 302 (Kathy).

We appreciate your cooperation, as the more we can properly recycle, the more we can reduce our tipping costs at the landfill.

### CYCLICAL ASSESSING UPDATES

The Town's new assessing contract includes cyclical updates. This means that 1/4 of the Town will be reviewed each year (data and listing information) toward the end goal of every fifth-year revaluation/recertification process required by the State. Assessors will be out in the field more often looking at all the housing stock. They will update photos and listing information and will ask to view your home if you are there when they visit. This is at the owner's discretion but is most helpful to the Town to ensure we have the best, most up to date information to arrive at your assessed valuation.

MRI personnel are in the field working on these properties, and they carry MRI Photo Identification and have with them, a letter from the Town (signed by the Town) with their name and vehicle information including license plate number. Currently Dan Scalzo and Bill Cafarelli are primarily working in Fremont collecting the data. The Selectmen's Office will always know when they are working in Fremont, so please feel free to call us if you have any questions. ## WASTE MANAGEMENT TOTERS

Waste Management has notified us that they are tagging broken toters for replacement. They have also brought to our attention that some single-family homes have two toters out for pick up each week. They are calling our office to check if they are a legal two family or in-law. If our records show they are not, then they

will be taking the second toter away. Per our contract with Waste Management each single-family home is only allowed one toter. Your cooperation is appreciated in this matter.

### FIRE PERMITS REQUIRED

As you may have seen in the news, the Spring 2016 forest fire season has already started, much earlier than normal, and with a far higher than normal incidence of Class 4 and Red Flag Warning Fire Danger days. Fires are raging across the country. Please remember these simple rules:

Every person, firm or corporation who kindles or causes to be kindled, any fire or shall burn or cause to be burned any material in or near the woodlands, except when the ground is covered with snow where you are burning **SHALL** obtain a written fire permit from the Forest Fire Warden in the town or city where the fire will be kindled, pursuant to NH RSA 227-L:17, I and II.

#### **CAMPFIRE PERMITS**

Camp or cooking fires may be kindled only with written permission of the landowner or agent and a written fire permit from the Forest Fire Warden. A camp or cooking fire is a suitable fire in a suitable place for the purpose of cooking a meal. A gas grill or charcoal fire in a container up and off the ground kindled by the landowner, or with landowner permission does not require a written fire permit.

Contact the Fremont Fire Department to renew your seasonal camp fire permit. This needs to be done on an annual basis.

### CHIMINEA BURNING DEVICES

Chiminea devices do fall under the jurisdiction of the Forest Fire Warden. In order to use these devices, you must obtain a written permit from the Warden every time you use it. The reason for this is that the units do not meet criteria to be considered an "enclosed" device, and as such are subject to the rules of open burning.

#### **RULES AND REGULATIONS**

A written fire permit shall be SUMMARILY SUSPENDED if any of the following fire permit restrictions are violated, and an Official Notice of Summons shall be issued:

- If a fire is kindled or material is burned between the hours of 9:00 am and 5:00 pm unless actually raining.
- If a fire is kindled or material is burned at an unspecified date, time, place, or if material not specified on the written permit is burned.
- If a fire is kindled or material is burned when weather is unfavorable in the opinion of the issuing authority or proclamation closing the woodlands is in force.
- If a fire is kindled or material is burned when specified assistance or suppression equipment is not present to control the fire.
- If permitee fails to keep the fire under control, or if the Director, Division of Forests and Lands, or his authorized agents or Warden feel that the material being burned is causing a hazard endangering life and/or property.
- If material being burned violates any state law, rule, or regulation or local ordinance and or New Hampshire Air Resources Division regulation regarding open burning.

### **OTHER REGULATIONS**

- All open fires shall be constantly attended until the fire is completely extinguished.
- Fires kindled, and material burned shall be not less than 50 feet from any structure and provisions shall be made to prevent a fire from spreading to within 50 feet of any structure. Fires in approved containers shall be not less than 25 feet from any structure.
- ♦ You must be 18 years of age to obtain a written fire permit.
- You also must be the landowner to obtain a permit. If you are not, written permission from the landowner must be submitted to the Fire Department. This permission must clearly state the dates the owner is permitting burning (and it can be done for the "season"), who they are giving

permission to, and their name, address, and contact telephone number.

Be sure your fire is completely and totally extinguished.
A buried fire is not an extinguished fire!

If you have questions, please contact the Fremont Forest Fire Warden Richard Butler through the Fire Station at 895 9634 or by calling Raymond Dispatch at 895 4222. The Fire Chief/Forest Fire Warden has office hours on Monday and Thursday evenings from 5:00 to 7:00 pm, and you can call Dispatch or the Station at any time for more information.

In Fremont, burn permits are only issued in the evening, weather conditions permitting. Call the above phone numbers for more information day to day.

The class day is depicted on the Smokey Bear sign in front of the Safety Complex Station at 425 Main Street. In general, when the fire danger is at 3 or above, no permits are issued for outdoor burning. It is solely at the discretion of the Warden on a daily basis, depending on the weather conditions.

### **WATER TESTING IN FREMONT**

### NH DES MtBE Remediation Bureau Information

The New Hampshire Department of Environmental Services MtBE Remediation Bureau recently mailed letters to some Fremont residents. These properties were identified as being served by private wells and located in an area that is *potentially* vulnerable to gasoline contamination. Additional letters will be mailed out in a few weeks.

For a limited time, the NHDES MtBE Remediation Bureau is extending this invitation to all Fremont residents that have a private well. This work will



be performed at no cost. Due to settlement fund restrictions NHDES can only pay for a MtBE-related (VOC) analysis, which also includes other common gasoline and chemical contaminates. If you elect to have additional analyses added, you will need to pay for those analyses.

If you did not receive a letter from NHDES you may still request to have your well tested, please contact Sarah Bartlett at (603) 271-0544 or sent an email to <a href="mailto:Sarah.Bartlett@des.nh.gov">Sarah.Bartlett@des.nh.gov</a> to set up an appointment.

Additional testing of private wells is recommended every 3-5 years to understand common problems with drinking water quality.
