The Universalist Society/Old Home Day Committee membership has diminished over the years and new members are needed to help perpetuate this unique piece of Fremont history for many years to come. The members meet once a year in the spring to organize the "Old Home Day Service" at the Old Meeting House which is always held on the third Sunday in August. ### TOWN CLERK UPDATES

**NEW PLATES:** State Parks license plates are now available. Free admission is granted to cars that have a valid State Park license plate on the car. The holder of a State Parks license plate will receive free admission for the registered vehicle and its passengers in most day-use State Parks in New Hampshire. The annual fee for the NH STATE PARK license plate is \$85.00 in addition to normal registration fees, plus a one-time new plate fee of \$8.00. All revenues earned from the purchase of the NH STATE PARKS license plate will be credited to the State Park Fund that supports the daily operations of the NH STATE PARKS system.

**REGISTRATION RENEWALS:** When renewing your vehicle registration or boat registration in person, you **MUST** provide the Clerk's office with the current registration or the renewal notice that you received in the mail. This is a State law. If you do not provide either of these documents, the Clerk's office **CANNOT** process the registration renewal without first printing a certified copy of your current registration at a charge of \$18.00 per registration.

**MID-STREAM PLATE CHANGES:** You are now allowed to make plate changes mid-stream during the year. You can switch to a vanity/initial plate or a "moose" plate at anytime. You will be charged the fees for the new plates to include an \$8.00 plate fee; a vanity/initial or "moose" plate fee if applicable and an \$18.00 replacement registration fee for the "new" registration. #### PLANNING A STAYCATION?

The Friends of the Fremont Library welcome all Fremonters to take advantage of the passes that are available to local and "not-toodistant" places to enjoy. We currently have passes for Fremont Library patrons to Zoo New England (allows ticket holders to The Stone Zoo and Franklin Park Zoo), Butterfly Place, The Children's Museum of New Hampshire, The Currier Museum of Art, and The Peabody Essex Museum. #### LIBRARY DIRECTOR POSITION OPENING

The Town of Fremont is accepting applications for a part-time Library Director to oversee operations of the Fremont Public Library. Director oversees a part-time staff of 3-4 to include a Children's Librarian, Young Adult Librarian and up to two other assistant staff members. The position is approximately 30-35 hours per week, permanent part-time, hourly/non-exempt and reports to a three member board of Library Trustees.

The Director directs and coordinates the daily operations of the Fremont Public Library. Other duties include: staff scheduling and oversight, budget development and implementation; purchasing and maintaining materials, management of personnel and discipline, and staff development. Director works closely with the Library Trustees and should be able to plan, organize, develop and direct a comprehensive program of library services, be responsive to the needs and preferences of patrons. Director needs the ability to organize data and keep clear and accurate records, prepare reports and maintain effective working relationships with patrons, the community, subordinates, other Town Departments, and the Library Trustees.

Effective written and oral communication skills are essential to the position. Comprehensive knowledge of library systems, principles, practices, procedures, tools, and new and emerging technologies necessary, with considerable knowledge of management principles and library administration as well as the Town of Fremont.

Position requires a background in Education and/or Library Science/Administration, including a minimum of five years experience in a Library setting, preferably at a management or supervisory level. Salary commensurate with experience.

#### LAND USE VOLUNTEER POSITIONS AVAILABLE

Do you have an interest in becoming a volunteer for the Town? Do you have some time to cultivate that interest? We need you!

The <u>Zoning Board of Adjustment</u>, <u>Planning Board</u> and <u>Conservation Commission</u> all have openings for Members and Alternate Members. The positions are 3-year terms and are open to residents interested in community service, the future of Fremont and land use. All meetings are in the basement Land Use meeting room at the Town Hall.

Below is a list of Land Use Boards/Committees that have openings and a brief function summary.

#### ZONING BOARD OF ADJUSTMENT (ZBA)

- The ZBA operates under NH RSA 673:3 and 674:33.

- The ZBA typically meets 1 to 2 times per month; at 7:30 pm on the fourth Tuesday of each month. For each case before the ZBA there is a site visit between public hearings so there is a potential for 2 meetings in a month.

 This Board works exclusively with applications requesting relief from articles of the Fremont Zoning Ordinance. These applications are for Special Exceptions, Variances, Appeals from Administrative Decisions, and Equitable Waivers of Dimensional Requirement.
 When there is no case the Board meets for work sessions to discuss various zoning articles and legal updates or issues that

discuss various zoning articles and legal updates or issues that affect the ZBA and its Members. - The position requires dedication of time and energy as well as the

- The position requires dedication of time and energy as well as the desire to implement and work with the Town's Zoning Ordinance and procedures. This knowledge can be gained at the work sessions as well as when you attend meetings and become familiar with regulations and ordinances.

- The Zoning Ordinance is on the ZBA page of the Town of Fremont website.

#### PLANNING BOARD

- The Planning Board operates under NH RSA 673 through 677.

- The Planning Board typically meets 3 times per month; at 7:00 pm on the first, third and fourth Wednesdays of each month.

(Sometimes less in the summer.) - This Board works on updates to the Town's Master Plan, Capital Improvements Plan, regulation amendments, and zoning amendments. The Planning Board also conducts preliminary meetings and public hearings for applications for Subdivision, Lot Line Adjustments, Site Plan Review, and Excavation operations. - The position requires dedication of time and energy as well as the desire to implement and work with the Town's regulations, ordinances and procedures, and a willingness to participate in community issues. This knowledge can be gained as you attend meetings and become familiar with regulations and ordinances. - All Planning Board Regulations are on the Planning Board page of the Town of Fremont website.

#### **CONSERVATION COMMISSION**

- The Conservation Commission operates under NH RSA 36-A; which empowers the Conservation Commission to provide "for the proper utilization and protection of the natural resources and for the protection of watershed resources of the Town".

- The Conservation Commission typically meets once per month; at 7:00 pm on the first Monday of each month. The Commission is involved in water resource management, the Town Forests and their trail systems, and possible purchase of property or easements for conservation. The Commission was instrumental in obtaining the "Protected River" status (and erecting the signs) for the local rivers.

#### ALTERNATE MEMBERS

Alternate Members of any Land Use Board are expected to attend meetings and participate so they can be informed and ready to step in to function in the place of an absent or disqualified Member.

#### REQUIREMENTS

You must be at least 18 years of age, a resident and registered voter of Fremont to be a Member or Alternate Member of any Land Use Board or Commission. The process for becoming a Board Member is for the candidate to sit in on several meetings to see if he/she feels that it is something he/she would be able, or want to pursue. If the Board Members agree with the appointment, they issue a recommendation to the Board of Selectmen and the candidate then meets with that Board for approval.
