CYCLICAL ASSESSING UPDATES

The Town's new assessing contract includes provisions to do cyclical updates. This means that 1/4 of the Town will be reviewed each year (data and listing information) toward the end goal of the every fifth year revaluation/recertification process required by the State. This means that assessors will be out in the field more often looking at all of the housing stock. They will update photos and listing information, and will ask to view your home if you are there when they visit. This is at the owner's discretion, but is most helpful to the Town to ensure we have the best, most up to date information to arrive at your assessed valuation.

They are beginning this summer with data review of manufactured homes and condominiums. MRI personnel are in the field working on these properties, and they carry MRI Photo Identification and have with them, a letter from the Town (signed by the Town Administrator Heidi Carlson or Selectmen's Clerk Jeanne Nygren) with their name and vehicle information including license plate number. Currently Jerry Quintal and Dan Scalzo are working in Fremont collecting the data. The Selectmen's Office will always know when they are working in Fremont, so please feel free to call us if you have any questions.

FREMONT FALL HIKING


The Fremont Open Space Advisory Group and the Fremont Conservation Commission are pleased to announce a series of hikes in and about the Fremont Town Forests to take place this fall. We will offer four hikes which will take place over a six week period. These hikes will visit both the Glen Oakes and Oak Ridge Town Forests as well as some of the surrounding open spaces. We will preview the NEW, one mile Barred Owl trail in the Smith section of Glen Oakes. All of the hikes will include at least some new sections we have not visited previously. All hikes will be rain or shine, unless weather is so severe to create a safety issue. Lightweight hiking shoes or a good walking sneaker will suffice. A hiking pole is a good idea, and we will have extras you can borrow.

Sunday, September 18th - Glen Oakes Barred Owl Trail - 2.8 miles total including the 1.1 miles of the Barred Owl Trail. We will leave from the Glen Oakes parking lot at the end of Andreski Drive at 12:30 PM.

Saturday, October 1st - Oak Ridge South and the Rail Trail - This 2 to 3 mile trip will leave from the Fremont Library, and will include the Oak Ridge South trail system, the rail trail, old woods roads, Tavern Road, and will cross a beaver dam. 12:30 PM at the Library.

Sunday, October 23 - Oak Ridge North - Besides visiting most of the Oak Ridge North trail system, we will also use Old Ridge Road, the Rail Trail and some old woods roads. This 2.5 mile trek will leave at 12:30 pm from the Oak Ridge North parking lot on Tavern Road, 1/2 mile south of North Road.

Saturday, **Nov 5th** - A Surprise Hike! - If all three hikes above happen as planned, we will announce a surprising new 4th location. Otherwise, we will use this as a make-up date. Stay Tuned!

EMERGENCY LANES

At a Public Hearing on June 22, 2016, the Fremont Board of Selectmen designated the following Class IV roads in Fremont NH as Emergency Lanes: Shirkin Road (dirt portion West of Beede Hill Road), Loon Way, Squire Road, and Paradise Drive. This was done pursuant to NH RSA 231:59-a to allow the Town, if absolutely necessary, to do minor repairs to said roads to facility public safety access only. Said work would only be done in consultation with the Road Agent, if sufficient funding could be found, and if a demonstrated emergent public safety need is identified. The Town does not intent to maintain these roads on a regular basis.

Please be reminded that there are many areas of private land abutting all of these Class VI roads and that you MUST have written landowner permission to be on said properties

FREMONT PD UPDATES

The Fremont Police recently replaced the 2010 and 2011 Ford Crown Vic cruisers with two 2016 Ford Police Utility cruisers. The new cruisers were purchased with a municipal lease to own program and the old cruisers were traded to help offset the cost.

The Fremont Police also recently obtained a US Government surplus American General HMMMV (aka Humvee) at no cost. The vehicle will be used during major storms or hazardous weather conditions for rescue or patrol purposes. The HMMWV will also be used to patrol the Shirkin Road and other inaccessible locations in town.



FREMONT HISTORICAL MUSEUM SUMMER HOURS

Fremont - formerly POPLIN was originally a part of Exeter from 1638 to 1742. The first settlers began settling in present-day Fremont during the 1720's. In 1742 Brentwood separated from Exeter and became incorporated as a new town taking with it the western section which later became Poplin - now Fremont. On June 22, 1764 Poplin in turn separated from Brentwood and became its own town. On July 8, 1854 the name of the town was changed from Poplin to Fremont in honor of the famous American West Explorer and later Civil War General JOHN CHARLES FREMONT who in 1856 became the first ever Republican Presidential Candidate. Though Fremont lost to Democrat James Buchanan he paved the way for Republican presidential candidate Abraham Lincoln's successful bid for the presidency in 1860.

The Fremont Historical Museum which houses a wide variety of intriguing and fascinating Fremont historical mementos will be open FREE OF CHARGE to the public on the following dates:

SUMMER ROAD IMPROVEMENTS

The Fremont Highway Department is currently executing several significant highway improvements. Sections of Whittier Drive are being reclaimed and about half of the road will be repaved. Extensive drainage work has been done on roadsides, including swales cleaned out and excess material hauled away so that water will flow properly through culverts. In total 3,705 feet will get a new ¾ inch base layer of hottop; and another 1,815 feet will be leveled with a 3/8 inch layer of new hottop.

Drainage work and tree trimming has also been done on Sandown Road. Sections are being reclaimed, with a $2\,\%$ inch binder course of hottop applied over a 2,500 foot section; and a 3/8 inch leveler course over an additional 1,900 feet.

The voters approved a Warrant Article for the Sandown Road work, and additional monies were allocated within the 2016 operating budget to allow for this paving work. We were helped in this endeavor by the lighter winter months in January to March 2016. The Town is working to catch up on some long overdue road work to keep our road network maintained.

We thank the voters for their approval of the Warrant Article to allow for the extra work to be done in 2016.

FREMONT SOUVENIR FLAGS

ROADS & THE RIGHT-OF-WAY

Obstructions in the Town's right-of-way are not permitted. Plantings, mulch, trees, rocks, and decorative pavers ARE NOT PERMITTED. These structures of any size obstruct drainage from the roadway and cause other road problems. Please help keep the ROW clear of all obstructions. This includes toys, basketball hoops and the like.

RSA 236:15 states that any building, structure or fence within or over any highway is a public nuisance. Please do not place any such items in the right-of-way as they are subject to being removed by the Highway Department. In general, the Town right of way is 13 feet on either edge of the paved surface.

No objects can be stored or parked in the ROW, including vehicles, trailers or equipment, and personal property.

Please also remember if paving or repaving your driveway this summer, you need a town Permit for Driveway Paving. These can be found on the Town's website or are available from the Selectmen's Office. The permitting process is to ensure proper drainage and a connection to the Town Road where your driveway is. If you live on a State road, you would contact NH DOT for a driveway permit. You do not need a permit to sealcoat your driveway.

FIRE APPARATUS UPDATES

Final work is being completed on the long-awaited new fire truck that was approved by Fremont voters in March of 2015. The Department hopes to take delivery of the new truck in September. A final inspection is scheduled for the end of July and lettering and

other final work will be done in August.



Additionally, using money encumbered from the Fire Rescue operating budget at the end of December 2015, the tank was replaced on the Department's Tank 4 extending its life for several more years.



Dear Ellis Families,

The Ellis School is moving to a single start time for the 2016-17 school year. The school day will start at 8:30 and end at 3:05 for all students. As a result, there will be changes to the morning drop-off and afternoon pick-up traffic patterns. We have collaborated with the Fremont Police and Fire Departments to create a safe and efficient procedure.

- Parents should use the Beede Hill entrance and turn right at the middle school playground. The designated drop-off/pickup area for all Kindergarten through 8th Grade students is alongside the North Side of the school. Staff will be available to assist students out of vehicles and help them into the building through the main entrance. Cars are to pull all the way up to the drop-off point before letting students out.
- The designated drop-off/pickup area for preschool students will remain at the main entrance of the school.
- The new K-8 drop off and pick up route is clearly marked with cones and signs.
- There is no parking in the drop-off lane. This is a drop-off or pick up lane only. If you need to exit your vehicle, please park in the parking spots at the front of the school. You may access the visitor parking lot via the South (Poplin Nursing Home) entrance.
- Please have your child ready to exit the vehicle when you arrive at the school in order to keep the flow of traffic running smoothly.
- Please make sure that your child is never in the parking lot area unattended. If you need to park for any reason, please escort your child to and from the parking spots, using the designated crosswalk for safety.
- Do not pick up or drop off students in the bus zone.
- Students may not be dropped off before 8:20. If you need supervision before 8:20, please contact Tanya, director of the YMCA extended day program at 642-3361 to set up childcare.
- Students arriving after 8:30 are considered tardy and will need to be signed in at the front office by a parent/guardian. Please park in the parking spots at the front of the school after 8:30.


