FREMONT HISTORICAL MUSEUM OPEN

The Fremont Historical Museum will be open on Saturday. September 14 from 10:00 am to 1:00 pm. Admission is always free. Fremont will be celebrating its 250th Birthday in 2014 so come and see hundreds of artifacts that reflect the town's colorful and eventful heritage dating back to the 1720's and 1730's when the town was first settled. See pictures of Fremont's Spaulding & Frost Barrel Cooperage that burned in a devastating fire 40 years ago on December 6, 1973 -- leaving 100 employees out of work at Christmas time. Fortunately the Cooperage rebuilt in 1974 and lasted another 25 years before permanently closing in 1999. GLEN OAKS TOWN FOREST CLOSED

The Conservation Commission is overseeing a managed timber harvest on approximately 75 acres of the Glen Oaks Town Forest with the help of Forester Charlie Moreno. A public bid process was undertaken with four respondents. The work has been awarded to Fred LeClair & Sons Logging of Fremont.

Work is anticipated to begin shortly, and while it is in progress, all trails within the marked are area CLOSED during the day while logging operations are in progress. The area will be signed at the kiosk at the end of Andreski Drive and in within the cut section. Please observe all posted signage and say out of the area during the day once the operation begins.

PRESS RELEASE

A Police Chief Search Committee was formed in April to assist the Selectmen in finding the Town's next Police Chief. The Committee consisted of Fremont residents including a retired law enforcement officer, and two area Police Chiefs. The position was posted throughout the month of May and resumes were received and reviewed by the Committee in early June. Following review of submitted applications, and Committee deliberation, the Committee interviewed four qualified candidates for the position.

The Committee then presented finalist recommendations to the Selectmen. The Board of Selectmen then conducted further interviews of the finalists. Following much deliberation, and consideration of the needs of the community, the Selectmen have hired Jon Twiss as the Town's next Police Chief. Chief Twiss comes to Fremont with 28 years of experience with the Derry Police Department and a strong and varied law enforcement background.

Please help us in welcoming him to the community. He began work in Fremont on August 1, 2013.

VEHICLE REGISTRATION RENEWALS

When renewing your vehicle registration or boat registration in person, you MUST provide the Clerk's office with the current registration or the "courtesy" renewal notice that you received in the mail. This is a State law. If you do not provide either of these documents, the Clerk's office CANNOT process the registration renewal without first printing a certified copy of the previous registration that will cost \$18.00.

MOTOR VEHICLE REGISTRATION RENEWAL & DOG LICENSING RENEWAL AVAILABLE ON-LINE!





Internet transactions are accepted through a kiosk to <u>renew</u> your motor vehicle registrations and <u>renew</u> your dog licenses from your computer at home. Customers will be directed to a secure web site through the kiosk. The Town of Fremont will receive all applicable fees. Customers are charged a convenience fee for the transaction.

All inquiries are directed through our software provider's website.

Also on the E-Reg site is an estimation tool to receive quick and convenient estimates for your vehicle registrations. The fees calculated are subject to change and may vary depending upon how, when and where you complete the registration process.

ID FOR VEHICLE REGISTRATIONS

When registering a vehicle with the Town Clerk's office you MUST present a valid photo id or driver's license in order for your transaction to be completed. This requirement has been issued by the NH Department of Safety – Fraud Unit.

VEHICLE REG REQUIREMENTS

When registering a **newly acquired vehicle** you MUST provide a bill of sale. The Clerk's office is required to make a photo copy of that bill of sale and submit it to the DMV. Also, when registering a newly purchased vehicle, whoever is listed as the owner or owners on the paperwork MUST appear in person at the Clerk's office to complete the transaction.

BOAT REGISTRATIONS

- Once you compete all of these steps, you will get an email each time one of the items is posted to the website. When you click on the link in your email, it will take you directly to the Newsletter, or other news item you have subscribed to.

You can also subscribe to TOWN NEWS and you will be notified when any new information is posted to the homepage of the website or emergency news is posted. This includes unanticipated office closures, changes to office hours, and news updates.

You can unsubscribe at any time using the same process, except you would chose "Remove my name."

DEPUTY TOWN CLERK / CLERICAL POSITION OPENING

The Town of Fremont has an immediate opening for a Deputy Town Clerk/Clerical Assistant. This is a Town Official position and would be appointed until the March 2014 Town Meeting.

Position performs a wide variety of NH statute-guided duties including overseeing elections and balloting, voter registration, registration of motor vehicles and dogs, vital statistics, and other tasks as outlined in the job description posted. Selected individual will be required to complete a minimum of five days of training with various state agencies in Concord NH.

The position requires interaction with the public and a wide variety of clerical duties in addition to the skills outlined in the posted job description, and careful attention to detail. Excellent recordkeeping, organizational, computer, and interpersonal skills are a must. Municipal Town Clerk experience preferred. Successful candidate will be required to submit to a background check. Position will be appointed by the Board of Selectmen. Annual stipend is \$500 with certain duties expected; and the position will also include 12-15 hours per week of clerical duties, paid at an hourly wage of \$12 per hour. NH DHHS IDENTIFIES FIRST POSITIVE TEST RESULTS OF THE YEAR FOR EASTERN EQUINE ENCEPHALITIS

Concord NH — The NH Department of Health and Human Services (DHHS) is announcing that one batch of mosquitoes in Exeter tested positive for Eastern Equine Encephalitis (EEE). This is the first finding of EEE in the State this year. This is in addition to the 6 batches of mosquitoes that have tested positive for West Nile Virus so far this season in NH. In 2012, there were 13 positives for EEE, including 9 mosquito batches and 4 animals.

EEE and WNV are transmitted by the bite of an infected mosquito. This finding does not change the low risk level in Exeter. "This is the first identified positive for Eastern Equine Encephalitis in New Hampshire this season, but unfortunately it is not unexpected," said Public Health Director Dr. José Montero. "These two viruses tend to appear in waves and some years there are more positives than others so we don't really know what the rest of the season has in store. This is all the more reason why people should take precautions against being bitten by mosquitoes."

Symptoms of WNV disease often appear 4 to 10 days after being bitten. If you or someone you know is experiencing flu-like symptoms, including fever and headache, contact your local medical provider. EEE is a more serious disease that carries a high mortality rate for those who contract the serious encephalitis form of the illness. Symptoms may include high fever, severe headache, stiff neck, and sore throat. There is no treatment for the disease, which can lead to seizures and coma. Symptoms usually occur 4 to 10 days after being bitten.

NH DHHS PREVENTION GUIDELINES FOR WNV AND EEE

1. Eliminate standing water and other mosquito breeding locations. In warm weather, mosquitoes can breed in any puddle that lasts more than 4 days!

· Remove old tires from your property.

- Dispose of tin cans, plastic containers, ceramic pots, or other containers. Don't overlook containers that have become overgrown by aquatic vegetation.
- Drill holes in the bottom of recycling containers that are left outside.

· Make sure roof gutters are clean and draining properly.

Clean and chlorinate swimming pools and hot tubs. If not in use, keep empty and covered and keep covers free of standing water.

· Aerate garden ponds or stock them with fish.

· Turn over wheelbarrows and change water in birdbaths at least twice weekly.

Turn over plastic wading pools when not in use.

- Remind or help neighbors to eliminate breeding sites on their properties.
- 2. Be aware of where mosquitoes live and breed and keep them from entering your home.
- Mosquitoes lay their eggs in standing water. Weeds, tall grass, and bushes provide an outdoor home for adult mosquitoes, including several species commonly associated with West Nile virus and Eastern Equine Encephalitis.
- Mosquitoes can enter homes through unscreened windows or doors, or broken screens. Make sure that doors and windows have tight-fitting screens. Repair or replace all screens in your home that have tears or holes.
- Resting mosquitoes can often be flushed from indoor resting sites by using sweeping motions under beds, behind bedside tables etc. and once in flight, exterminated prior to sleeping at night.
- 3. Protect yourself from mosquito bites.
- · If outside during evening, nighttime, and dawn hours when mosquitoes are most active and likely to bite, children and adults should wear protective clothing such as long pants, long-sleeved shirts, and socks.
- Consider the use of an effective insect repellent, such as one containing DEET. A repellent containing 30% or less DEET (N,N-diethyl-methyl-meta-toluamide) for children and adults. Use DEET according to the manufacturer's directions. Children should not apply DEET to themselves. Repellents that contain Picaridin or oil of lemon eucalyptus have also been determined to be effective.

Vitamin B, ultrasonic devices, incense, and bug zappers have not been shown to be effective in preventing mosquito bites.
