On Thursday October 23rd at 6:30 pm, the Fremont Library will present an informative and enlightening program "Haunted Lighthouses of New England. " Jeremy D'Entremont, author and lighthouse historian, will present this interesting and fascinating program about New England's Lighthouses. Jeremy is a leading expert on New England's historic lighthouses. He is the author of more than a dozen books, including The Lighthouse Handbook: New England and Ocean-Born Mary: The Truth Behind a New Hampshire Legend. His website, "New England Lighthouses: A Virtual Guide" at www.newenglandlighthouses.net. was launched in 1997. He is the historian and past president of the American Lighthouse Foundation, and founder of the Friends of Portsmouth Harbor Lighthouses. He has appeared on the History Channel, the Travel Channel, Public Television, and National Public Radio speaking about lighthouses and maritime history. This program is free and open to the public. #### **FALL FOLIAGE HIKE**

The Fremont Open Space Advisory Group and the Fremont Conservation Commission are holding the Fall Foliage Hike on Saturday, October 18th at 1:30 pm. The hike will showcase the NEW Cooperage Trail, which has recently been completed. The trail is a wide, gentle, 1/2 mile path (1 mile round trip) connecting the back of the cooperage housing development with Beede Hill Road. It is well suited for a wide range of walkers! Come check out the new trail and learn about how it came to be. DIRECTIONS: From Main Street (Rt. 107) take Spaulding Road all the way to the end to the cul-de-sac.

For the second part of our hike, we will relocate to the Glen Oakes Town Forest at the end of Andreski Drive (Take Main Street to Copp Drive, left on Andreski Drive). Arriving there about 2:30, we will explore the Homestead trail loop to see the effects of last winter's logging and to learn about its benefits. This 1 1/4 mile walk should be finished by 3:30 pm. Glen Oakes Town Forest has been funded and protected, in part, with assistance from the NH Land and Community Heritage and Investment Program (LCHIP) and by the NH State Conservation Committee's License Plate (Moose Plate) grant program.

### NH GENERAL ELECTION NOVEMBER 4TH

The NH General Election will be held on Tuesday November 4, 2014. Polling will be at Ellis School, 432 Main Street in Fremont with polls open from 7:00 am to 8:00 pm.

Supervisors of the Checklist will meet at the Fremont Public Library from 11:00 to 11:30 am on Saturday October 25, 2014. This is the last time to register to vote prior to the November 4<sup>th</sup> election. All Supervisor sessions are held at the Fremont Public Library at 7 Jackie Bernier Drive in Fremont.

Residents may also register to vote with the Town Clerk during normal office hours. The last day to register with the Clerk is during her hours on Friday October 24<sup>th</sup> from 9:00 am to 12 noon.

New registrants may register the day of the election on November 4, 2014, with the Supervisors of the Checklist. Positive proof of ID is required to register and to be able to vote.

The LAST DAY that an absentee ballot can be accepted is Monday November 3, 2014 between 3:00 and 5:00 pm with the Town Clerk. The Town Clerk's Office will be open from 3:00 to 5:00 pm on November 3, 2014 solely for the purpose of absentee balloting. The Town Clerk / Tax Collector Office is CLOSED on Election Day.

#### POLITICAL ADVERTISING SIGNS

NH RSA 664:17 Placement and Removal of Political Advertising: "No political advertising shall be placed on or affixed to any public property including highway rights-of-way or private property without the owner's consent. The candidate shall remove all political advertising no later than the second Friday following the election unless the election is a primary and the advertising concerns a candidate who is a winner in the primary. Signs shall not be placed on or affixed to utility poles or highway signs. Political advertising may be placed within State-owned rights-of-way as long as the advertising does not obstruct the safe flow of traffic and the advertising is placed with the consent of the owner of the land over which the right-of-way passes.

No person shall remove, deface, or knowingly destroy any political advertising which is placed on or affixed to public property or any private property except the owner of the property, persons authorized by the owner of the property, or a law enforcement officer removing improper advertising. State, City, or Town Maintenance or Law Enforcement Personnel may remove political advertising placed on or affixed to any public property. Political advertising removed prior to election day by state, city, or town maintenance or law enforcement personnel shall be kept for one week at a place designated by the state, city, or town so that the candidate may retrieve the items.

As it pertains to the highway right-of- way provision, the Fremont Board of Selectmen, after consultation with the Fremont Town Clerk and Moderator, has outlined the following guidelines:

- No political signs shall be placed on Town Property outside of the road right-of- way.
- Within the road right-of-way [generally 13 feet from the edge of pavement or travel way], signs may only be placed with the direct abutter's permission. This refers to the abutter on that side of the street.
- 3. At the polling entrance, unattended political signs may be placed only on the actual polling day during open polling hours [7:00 am to 8:00 pm]; and only in the designated area as determined by the Moderator. The designated area will be appropriately marked and placed in an area that will

- not obstruct or hinder the safe flow of traffic. (This designated area allows the Town of Fremont to abide by the Attorney General's rules). Signs shall be removed immediately following the election.
- A candidate or the candidate's representative must attend all other signs which will be permitted in an area designated by the Moderator in accordance with RSA 659:43.

If you have any polling-related questions, please call the Town Clerk at 603 895 8693.

The Town of Fremont designates the Fremont Safety Complex as the storage location for any political advertising signs removed for improper placement; or those found after having been displaced by wind or weather conditions. # WREATHS ACROSS AMERICA

Remember, Honor, and Teach is the mission of the Wreaths Across America Program. Through this program wreaths are placed on the gravesites of veterans during the holiday season. Ceremonies honoring servicemen and women, both past and present, are held at veterans memorial monuments across the nation. These events coincide with the annual ceremony and laying of wreaths at Arlington National Cemetery in our nation's capital on the second Saturday in December.

Once again, we would like to place wreaths on the veterans' gravesites in Fremont and East Kingston. Approximately 300 veterans are buried in Fremont and East Kingston. With your help we will be able to honor each of them with a wreath of remembrance. Wreaths cost \$15 each. Ten dollars pays for the construction and delivery of the wreath. The remaining \$5 will be used to support two local Veterans Centers that provide for the needs of our homeless veterans.

Assistance can occur in a variety of ways. Community members and groups are needed to unload the truck when the wreaths are delivered, to place the wreaths on the gravesites in December and remove them in the spring, and to purchase of one or more wreaths.

We encourage not only adult participation, but look forward to the participation of our youth. This project provides the opportunity for our children to understand that the sacrifices made by our servicemen and women have secured the freedoms we are privileged to experience in our country today. Their participation ensures that our veterans will be remembered and honored in the years to come.



#### **NEW VEHICLE REGISTRATIONS**

When registering a vehicle that is less than 15 years old, you must provide either of the following: the title, signed by the previous owner or the title application that the dealer gave you. If you have the title, all owners MUST be present when registering, with their valid ID, to sign the title application. If you have the title application, anyone can register your vehicle for you, on your behalf, however they must present their ID.

#### TRANSFER OF PLATES

If you are transferring plates from your old vehicle to another one you MUST turn in the current registration for the old vehicle. This has to be sent to the state with the transfer documentation. Failure to have this document in hand will require you to purchase a duplicate at a cost of \$18.00.

Please note: PLATES CAN ONLY BE TRANSFERRED FROM ONE VEHICLE TO ANOTHER IF THE PRIMARY OWNER REMAINS THE SAME.

# MOTOR VEHICLE REGISTRATION RENEWAL & DOG LICENSING RENEWAL AVAILABLE ON-LINE!





Internet transactions will be accepted through a kiosk to <u>renew</u> your motor vehicle registrations and <u>renew</u> your dog licenses from your computer at home. Customers will be directed to a secure web site through the kiosk. The Town of Fremont will receive all applicable fees and there is no charge to the Town for the electronic payment. Customers are charged a convenience fee for the transaction.

All inquiries are directed through our software provider's website and there is no direct access to the Town's computers or their systems.

# **VEHICLE REGISTRATION RENEWALS**

When renewing your vehicle registration or boat registration in person, you **MUST** provide the Clerk's office with the current registration or the "courtesy" renewal notice that you received in the mail. This is a State law.

#### ID FOR VEHICLE REGISTRATIONS

When registering a vehicle with the Town Clerk's office you MUST present a valid photo id or driver's license in order for your transaction to be completed. This requirement has been issued by the NH Department of Safety – Fraud Unit.

# MUSEUM AND ATTRACTION REIMBURSEMENT PROGRAM

We found that museum and attraction passes are costly especially when they are not used enough or the Library doesn't have the pass to the attraction or museum you want to go to.

So The Friends of the Fremont Library came up with a new reimbursement program. Here is how it works:

Take your family to any museum or family attraction in New Hampshire or Massachusetts. Keep your ticket receipts. Bring them into the library. Complete a reimbursement form. Once received, a check from the Friends of the Fremont Library will be sent to you for up to \$5.00 per person with a maximum of \$25.00 per family. A family can be reimbursed once each calendar year.

So we hope you will take your family to one of the many places available in our own state or in Massachusetts and let us reimburse you for some of the cost.
