BUDGET SEASON

The Budget Committee meets on Wednesdays December 1, 8, 15, 2021, at 7:00 pm. These meetings will include sessions with Town and School Officials for final reviews of Town and School District budgets. Most meetings are held in the basement meeting room, except those nights which conflict with the Planning Board. On the first and third Wednesdays, the Budget Committee will meet on the Main Floor at the Town Hall.

CANDIDATE DECLARATION AND IMPORTANT VOTER INFORMATION for Upcoming Town & School District Elections and Meetings

Tuesday January 11, 2022 by 12 noon – Town Petitioned Warrant Articles are due at the Select Board's Office, Town Hall, 295 Main Street.

SAU 83 is accepting School District petition articles, contact them for time of filing. The deadline of January 11, 2022 is the same for both Town and School District articles.

Any petition articles, all Town and School District budgets and Warrant Articles will be discussed at the Public Budget Hearing on Wednesday January 12, 2022. The hearing begins at 7:00 pm and will be held at the Ellis School in the Gym to allow for social distancing. The meeting will be live broadcast on FCTV Channel 22, and rebroadcast throughout the voting season, until Town Meeting Voting on Tuesday March 8, 2022. Emails will be accepted during the meeting at hcarlson@fremont.nh.gov or texts with questions to 603 418 4416 and we will endeavor to offer a Teams/Zoom option.

Tuesday January 18, 2022 - Last day for new registrants who want to register prior to Candidate Declaration Period.

Supervisors of Checklist will meet from 7:00 to 7:30 pm at the Fremont Public Library. This is the last time to register to vote prior to the Deliberative Sessions. If you are not registered, you cannot vote at either Town or School Deliberative Sessions. No registrations can be accepted at Deliberative Session.

Please bring proper ID and proof of residency to register to vote and to all elections. The State has tightened up the forms, and if you don't have an ID with a Fremont address on it, you will need to bring documentation from form Verifiable Action of Domicile RSA 654:7V (available on the Town's website, from the Supervisors at a sign-up session or from the Town Clerk.)

DELIBERATIVE SESSIONS: In response to widespread community interest, we will again hold the Town and School Deliberative Sessions on the SAME DAY, Saturday February 5, 2022. The meetings will be posted for 9:00 am and we will begin with the School District session. Once complete, there will be a brief intermission while the Town Moderator and Select Board set up, and the Town's meeting will then begin. The snow date for these meetings is Saturday February 12, 2022 at 9:00 am, and the meeting will be held at Ellis School in the Gym. We are still in the planning stages of how to conduct these meetings in a safe manner. Please watch for updates as the situation is still very fluid with the increase in Covid cases statewide.

Supervisors of the Checklist will meet on Saturday, February 26, 2022 for final correction of the checklist before Town and School Election Day. They will meet from 9:30 to 10:00 am at the Fremont Public Library. You can still register on election day, March 8, 2022.

PUBLIC HEARING NOTICE

In accordance with NH RSA 675:3, you are hereby notified that the Fremont Planning Board will hold a Public Hearing on December 1, 2021 at 7:00 pm at the Fremont Town Hall basement meeting room, for review of the following proposed amendments to the Town of Fremont New Hampshire Zoning Ordinance:

Article 11: Amend the limitations on number bedrooms/family units for multiple unit dwellings by allowing two bedrooms/family units for 5 or more family units. This amendment would eliminate the restriction of one bedroom/family unit for 7 to 8 family unit dwellings and clarify the allowable bedrooms for more than 8 family unit dwellings.

Article 9: Removal of example language in Section 902. The example language is not applicable for a lot on which two (2) family units are considered and the existing language is sufficiently clear.

A copy of the detailed language is available on the Town's website on the Planning Board page, or at the Fremont Town Hall during regular business hours. You are invited to attend the hearing, in person, by counsel or agent. Written comment will be accepted up until the date of the Hearing. The final form of the amendments will be on the Warrant for voter consideration at the March 2022 Town Meeting.

WREATHS ACROSS AMERICA SHEPHERD'S HOOKS

If you've walked through Fremont's cemeteries recently you may have noticed shepherd's hooks on our 216 veterans' gravesites. These shepherd's hooks, which hold hanging plants, will hold wreaths honoring our veterans during the holiday season as a part of the Wreaths Across America Program in Fremont.

Walmart Distribution Center in Raymond, NH provided a grant to purchase the hooks for the purpose of holding the wreaths that family members, friends, community members and local businesses sponsor. One of our sponsors suggested that the wreaths be displayed so that everyone could see them. We are so grateful to our sponsor and to Walmart for helping us honor our veterans in this very special way.

WHO WANTS TO TALK ABOUT POOP?

Usually, nobody wants to talk about poop. Or see it or smell it. That's why we have toilets that flush that stuff away. But what happens to it then? Well, if you live in

a rural community like Fremont, it goes into your septic tank along with wastewater from your laundry, your dishwasher and your bathtub drain.

So, who wants to talk about septic tanks? Usually, nobody wants to talk (or think) about them either. Fortunately, there are professionals in our area that think about septic systems a lot! To keep your septic system working properly for a very long time, you need to contact one of those professionals every two years and have them pump out your septic tank. It's quick and easy and then you don't have to think about it again for another two years! Recycle Beyond the Bag

Grocery bags, bread bags, case overwrap, dry cleaning bags, newspaper sleeves, ice bags, wood pellet bags, zip lock & other re-

sealable bags, produce bags, bubble wrap, salt bags, and cereal bags. All materials must be clean, dry and free of food residue. Recycle your household bags & wrap into Trex's Earth-Friendly Composite Decking and Railing! Drop off box located in front of the Town Hall.



TOTERS & RECYCLING

The toter collection system has helped to increase recycling and

SAVE TAX DOLLARS. One toter is distributed per household and all of your trash must be in that toter to be collected.

All trash must be bagged before putting it in your toter. This helps to eliminate trash from blowing and separating.

- Trash and recycling should be at the curb by 6:30 am on your collection day.
- NO YARD WASTE is allowed for pickup. This includes grass clippings, leaves, and brush. Look for other acceptable ways to compost this material. Start a compost pile in your yard and create good soil material from scraps!
- NO HAZARDOUS MATERIALS are allowed for pickup.
- Trash will not be retrieved from sheds beside the road.
- No construction debris of any kind is accepted for pickup.
 Consider making arrangements for a dumpster or the Best
 Way facility in Raymond for your disposal needs. The You
 can also try the Bestway Facility at 603 895 6273 for more
 information on bulky items you may be able to take there.

Waste Management has three basic rules for recycling.

- 1. Recycle clean bottles, cans, paper and cardboard.
- 2. Keep food and liquid out of your recycling.
- 3. No loose plastic bags and no bagged recyclables.

Also, a reminder to not put paper recycling out in the rain. For a detailed list of what is acceptable for recycling go to the Town Website Fremont.nh.gov under recycling for more information. Waste Management asks that recycle bins not weigh more than 40 pounds as they need to lift these containers by hand. Placing multiple bins for recycling is acceptable.

PART-TIME POSITIONS CEMETERY SUPERINTENDENT

The Town of Fremont is seeking applicants for a part-time, Cemetery Superintendent within the Town's cemeteries. Hours are part-time and flexible; all work is weather-dependent and sometimes weekends are necessary. Suitable candidate is a self-starter and able to work with minimal supervision, primarily responsible for lawn care and mowing, trimming, leaf raking, and general cemetery maintenance and upkeeping. Position may supervise one or two other part-time labor positions.

Position busiest during the months of May through early July; with other maintenance throughout the growing season. Position primarily supervised by the Town Administrator. Available hours could be 10-20 per week, widely fluctuating based on needs of the Town. Days and work hours can be flexible, depending on candidate and scheduling needs. DO I HAVE A SEPTIC SYSTEM?

You most likely have a septic system if:

- You are on well water and you don't pay a water or sewer utility bill.
- Your neighbors have septic systems.

- to prevent washing away the healthy bacteria your system needs. Conserve water Fix leaky faucets and toilets
- machine loads and and other large water uses (showers, dishwashers, etc.) gives your system Space out water use Spreading out washing a chance to work between loads.
- Only flush human waste and toilet paper "Flushable" may only mean that it fits down the drain... if in doubt, throw it out.
- Don't park or drive on your system This can easily damage the septic system.
