FREMONT FIRE RESCUE DEPARTMENT UPDATE on HOW TO OBTAIN AN OUTDOOR BURN PERMIT

On December 1. 2022 the Fremont Fire Rescue Department will be changing the way you get a burn permit. You will need to call the Fremont Safety Complex at 603 895 9634 and leave a message in the mailbox for the duty officer or you can go online to the NH Division of Forest and Lands and purchase a permit online. The NH Fire Permit online kiosk is: https://nh.burnsafeamerica.com/

Follow the instructions to get a permit online when weather conditions permit. Permits are issued on a day-to-day basis as fire weather conditions permit.

To get a permit locally, when the station is manned, just ask for the Fire Rescue Duty Officer and you will be transferred. If you call in after hours, you will be directed to push 4 for a burn permit, or you can dial extension 201 for the Duty Officer Mailbox. This will be checked periodically by the Duty Officer and calls returned.

If you want a permit, you must call in before 5:00 pm to leave your name, address and phone number.

You can also consult the NH Division of Forests and Lands Permit Brochure at https://www.nh.gov/nhdfl/documents/fire-law-brouchure.pdf to get more information on the regulations and guideline.

Effective December 1, we will no longer be using the contact number for the Raymond Dispatch Center (603 895 4222). Please update your records immediately with the new burn permit call number of the Safety Complex at 603 895 9634. Our Dispatch Services will change-over to the Rockingham County Sherriff's Department in December.

A permit is required for any outside burning unless the ground is covered in snow. Please call the station at 603 895 9634 for any questions on outdoor burning.

SECOND ISSUE TAX BILLS ARE DUE DECEMBER 1, 2022. The Tax Collector's Office at the Town Hall will be open the following dates for payment of taxes:

Monday & Friday 9:00 am to 12 noon **Tuesday 8:00 am to 12 noon (these hours have changed)** Wednesday 3:00 to 7:00 pm Thursday 9:00 am to 5:00 pm

The Town Hall is open. You can drop your bill off while the Select Board's Office is open, or in the drop box, but you cannot get a paid receipt unless you visit the Tax Collector during open hours or leave a stamped return envelope with your payment. In these uncertain times, you may continue to use the drop box or mail, as we check both frequently.

If you have questions about your assessment or an abatement, credit or exemption, please feel free to stop by the Select Board's Office for information. All property assessing records are public information. You can access the information online from the Town's website at

https://www.fremont.nh.gov/assessing/pages/online/property/look

We send updates several times a year to the Vision site, and you can see the most recent date of updates when you log on. The Select Board's Office is open Monday and Friday 8:00 am to 12 noon; Tuesday and Wednesday 8:00 am to 4:00 pm; and Thursday from 9:00 am to 5:00 pm, and this is where the most current information is housed. A public (always up to date) terminal is available when the Select Board's Office at Town Hall is open. We will also be glad to mail out your property card to you if you call or email us and make a request.

If you feel that your property is disproportionately assessed, or there are listing errors on your card, you can file an abatement. Our abatement information sheet is available at the Town Offices and on the town website at

https://www.fremont.nh.gov/assessing/pages/abatements

Abatement forms are also available at the Select Board's Office. You need Form *Taxpayers 76:16 Abatement Application to Municipality.* You can also call or email the Select Board Office and we will send one out to you. Abatement forms are DUE no later than Wednesday MARCH 1, 2023 at 7 pm. A postmark of up to March 1, 2023 will be accepted. Postmarks after March 1, 2023 cannot be

accepted. An abatement left in the drop-box after the Tax Collector closes at 7 pm on March 1 cannot be accepted as timely.

You can drop off tax payments with a stamped self-addressed returned envelope, and the Collector will mail out your receipt. The Select Board's Office and Tax Collector's Office are located at Fremont Town Hall, 295 Main Street: on the main floor.

PLANNING BOARD PUBLIC HEARING – ZONING ORDINANCE CHANGES FOR MARCH 2023 TOWN MEETING

In accordance with NH RSA 675:3, you are hereby notified that the Fremont Planning Board will meet on December 7, 2022 at the Fremont Town Hall basement meeting room, 295 Main Street, Fremont, NH 03044, at 7:00 pm to hold a Public Hearing for the following proposed amendment to the Town of Fremont New Hampshire Zoning Ordinance:

Article 4: Add definitions for Motor Vehicle Repair Shop and Motor Vehicle Sales to clarify land uses in addition to and in lieu of the current category titled Motor Vehicle Showroom, respectively.

Article 7: Revise the Table of Uses to include newly defined uses including Motor Vehicle Repair Shop and Motor Vehicle Sales and to indicate in which districts they are allowed, under what conditions they are allowed, and in which districts they are prohibited.

Article 12: Remove from the Aquifer Protection District the definition in Section 1203.4 for Animal Feedlot. Remove Animal Feedlot from Section 1203.8.D(9) – Prohibited uses in the Aquifer Protection District.

Article 13: Add text to Article 1301.1 – Elderly Open Space, pursuant to RSA 674:17, IV, to indicate how certain incentives under this ordinance may be applicable to development of workforce housing.

A copy of the detailed language is available on the Town's website or at the Fremont Town Hall during regular business hours. You are invited to attend this, in person, by counsel or agent. The final form of the amendment will be on the Warrant at the March 2023 Town Meeting.

The deadline of January 10, 2023 is the same for both Town & School District articles. Any petition articles, all Town & School District Budgets and Warrant Articles will be discussed at the Public Budget Hearing on Wednesday, January 11, 2023 with a snow date for Thursday January 12. Location will depend on current conditions and will most likely be held at Ellis School in the gym. The hearing begins at 7:00 pm. The meeting will be live broadcast on FCTV Channel 22 and rebroadcast through Town & School Voting on Tuesday March 14, 2023.

Tuesday January 24, 2023 is the last day for new registrants who want to register prior to Candidate Declaration Period. Supervisors of Checklist will meet from 7:00 – 7:30 pm at the Fremont Public Library. This is also the last time to register to vote prior to Deliberative Sessions. If you are not registered, you cannot vote at either Town or School Deliberative Session in February.

Please bring proper ID and proof of residency to register to vote and to all elections. The State has tightened up the forms, and if you need to bring documentation from form Verifiable Action of Domicile RSA 654:7V (available on the Town's website, from the Supervisors at a sign-up session or from the Town Clerk).

WINTER PARKING BAN

It's that time of year again!

According to the Town of Fremont Parking Ordinance: It shall be unlawful for any person to stop, stand or park a motor vehicle at any time contrary to any of the following provisions of this Section unless otherwise directed by a Police Officer.

- Within the Town of Fremont, from November 15 to April 1, no parking is permitted on any public street or any townowned right of way, or in any town-owned parking lot between 12:00 midnight and 6:00 am.
- 2. In the event of a winter snowstorm requiring snow plowing and/or removal as deemed necessary by the Fremont Road Agent, it shall be unlawful for any person having custody and/or control of any vehicle to park or cause the same to be parked within the public right of way during a snowstorm. Vehicles interfering with snow plowing or removal operations shall be towed at the owner's expense.



Final 2022 Drought Update

November 10, 2022

Despite receiving less than average amounts of rain in October and early November, drought conditions have improved. According to the U.S. Drought Monitor, currently, 3.23% of the state in the Seacoast Region and a very small area in the southwest corner of the state is experiencing moderate drought, 32.76% of the state remains abnormally dry, and 64% of the state is under normal conditions.

New Hampshire is expected to receive from 1.25"- 3" of rain on Friday night and Saturday morning. The least amount of rain is expected to fall on the Seacoast Region, which is also the driest part of the state.

The 6-10 day and 8-14 day outlooks lean toward below normal precipitation and favors below normal temperatures.

The long-term seasonal outlooks for November, December, and January indicate equal chances of below-normal, normal, and above-normal precipitation and lean toward above normal temperatures.

TRASH INFORMATION

I'm cleaning out the garage and have a lot of refuse to get rid of right away. Where can I dispose of it?

The automated refuse collection program is not intended to provide this type of service. The resident must be responsible for the disposal. For larger projects Waste Management or other vendors can also provide temporary containers of varying sizes for your needs.

The Town does offer two annual BULKY drop-off events for this type of disposal. Fall Bulky Day is October 29th, don't miss it!

Your toter must allow the top to be fully closed in order for pickup. If you have bags sticking out or overflowing, it will not be collected. Consider another recycling bin if you need space in your toter.

Be sure and place your toter at least three feet away from any other item, including from your recycling bin.

All trash must be bagged within the toter. Please use discretion when putting out recyclables. Plastics will blow in the wind, and paper that gets wet in the rain is NO longer recyclable.



ARE YOU BEHIND IN PAYING YOUR MORTGAGE, PROPERTY CHARGES, OR UTILITIES BECAUSE OF COVID-19?

The NH Homeowner Assistance Fund provides assistance to eligible residents who are past due in paying their home mortgage, property taxes, home insurance, association fees, or utilities due to Covid-19 pandemic. Apply at www.HomeHelpNH.org

ELIGIBLE HOMEOWNERS

- Must have experienced a COVID-19 pandemic related reduction in income or increase in expenses that occurred after January 21, 2020 or began prior to but continued after that date.
- Must own and occupy, as their primary residence, the New Hampshire property for which assistance is requested.
- Must have income (s) of equal to or less than 125% of Area Median Income.

ELIGIBLE PROPERTIES: Must be owner-occupied or in the case of a land contract or contract for deed, occupied by the documented buyer. Eligible properties include:

- A single-family (attached or detached) properties
- Condominium units
- 1–4-unit properties where one of the units is the homeowner's primary residence
- Manufactured/modular homes permanently affixed to rest property and taxed as real estate
- Manufactured homes not permanently affixed to real property but with a Title Certificate or Statement of Ownership in the homeowner's name

NEW HAMPSHIRE FUEL & ENERGY ASSISTANCE PROGRAM

The legislature recently approved \$25 million in State General Funds for the State Emergency Fuel Assistance Program (SEFAP) and \$10 million in General Funds for the State Supplemental Electric Benefit Programs (SSEBP). Southern New Hampshire Services, the Community Action Program administering the funding for the State program for District Three, encourages all District Three residents who believe they might be at or below 75% of State Median Income to apply - disbursements are anticipated for December.

Any residents who apply and are below the 60% State Median Income will be enrolled in the Fuel Assistance Program (FAP). Any residents who apply and are between 61% - 75% State Median Income, which does not meet the regular fuel assistance guidelines, will be in the system and ready to be enrolled in the new Emergency State Program with a benefit being paid out as early as December.

PFAS WATER TREATMENT REBATES

The Per- and Polyfluoroalkyl Substances (PFAS) Removal Rebate Program for Private Wells is now accepting applications. The program provides rebates to private well users for up to \$5,000 for the installation of PFAS treatment or up to \$10,000 for a service connection to a public water system.

Eligible private well users must be able to document an exceedance of a regulated PFAS compound(s) with no offer of alternate water from a third party. An exceedance would be a result above New Hampshire's Ambient Groundwater Quality Standards (AGQS) for four PFAS compounds, which are: 12 parts-per-trillion (ppt) for perfluorooctanoic acid (PFOA); 15 ppt for perfluorooctane sulfonic acid (PFOS); 18 ppt for perfluorohexane sulfonic acid (PFHxS); and 11 ppt for perfluorononanoic acid (PFNA).

"New Hampshire leads the country in identifying PFAS contamination and acting on those findings," said Governor Chris Sununu. "These rebates will go a long way to help hundreds of homeowners affected by PFAS contamination to connect to clean drinking water sources or install treatment systems for their homes." NHDES has collected more than 7,200 PFAS samples from approximately 6,200 wells across the state and has identified several thousands of locations that exceed one or more of the

While there are provisions in state rules for parties that are responsible for contamination of groundwater to remedy water supply wells that violate AGQS, not all PFAS contamination found in the state has been attributed, either technically or legally, to a responsible party. In instances where there is no identified responsible party for a contaminated water supply well, the burden of providing safe drinking water resides with the well owner. Third parties have addressed over 1,000 wells that exceed AGQS for PFAS by providing alternate water, either temporarily or permanently, in accordance with state rules. If NHDES sampled your well, an email or letter has been sent to you indicating that the program is accepting applications. If you sampled your well yourself

or hired someone else to sample your well, please email pfasrebateprogram@des.nh.gov.

Eligible applicants can be reimbursed for the installation of treatment or a service connection back to September 30, 2019, "This innovative PFAS Removal Rebate program provides helpful funding for homeowners burdened with the costs of treating wells contaminated with PFAS above New Hampshire's drinking water standards," said Bob Scott, NHDES Commissioner. Funding for the program is provided by the New Hampshire Drinking Water and Groundwater Trust Fund and surplus funding from the State General Fund authorized under HB 1547. FINANCIAL ASSISTANCE AVAILABLE FOR LOW-INCOME RESIDENTIAL **WELL OWNERS IMPACTED BY** DROUGHT, OTHER NATURAL **DISASTERS**

The New Hampshire Department of Environmental Services (NHDES) announces a new program to provide short-term relief and financial assistance for low-income residential well owners experiencing irreversible deterioration of water supply quantity or water quality caused by droughts or other types of natural disasters. The Water Assistance for Natural Disaster Impacts to Low-Income Residential Well Owners (WAND) program is funded by a \$500,000 grant from the Drinking Water and Groundwater Trust Fund (DWGTF).

In general, projects that restore the homeowner with a reliable and safe source of drinking water are eligible in this program, subject to review and approval by NHDES. This may include, if feasible, connecting the homeowner to a nearby existing community water system, rehabilitation of the well, or replacing the well. Additionally, recognizing that each well has unique water quality characteristics and challenges, capital costs to install treatment may be included as an eligible project cost.

The WAND program may also provide immediate short-term relief with a delivery of bottled water where available or financial assistance to purchase bottled water, if requested while residents are waiting for their well improvement project to be completed. The bottled water provision will terminate upon completion of the water supply well project; if the applicant is determined to be ineligible for financial assistance; or, at the discretion of NHDES.

To prove eligibility, applicants must demonstrate their low-income status and that a drought, natural disaster or extreme weather event as determined by NHDES has adversely affected the supply or quality of water from their private well. The affected well must be associated with the eligible applicant's primary residence that they own, and the issue must be verified by a licensed New Hampshire water well contractor and/or pump installer. Low-income eligibility and the amount of financial assistance available is determined based on family size and total household income. Information on the eligibility criteria e can be found on the DWGTF website and

Immediate actions customers can take now:

- Use the new <u>Cooling Calculator on Eversource.com</u>. The tool helps customers understand how much electricity their current cooling system uses and the impact of small changes to temperature settings.
- Keep air conditioners set at or near 78 degrees a
 generally comfortable temperature that requires less energy
 to reach and maintain than cooler temperatures. For every
 degree higher on the thermostat, the air conditioner will use
 1-3% less electricity.

Additional tips for keeping temperatures and energy costs down:

- Don't block air flow. Keep air vents clear of obstructions such as furniture, curtains, and rugs. For those with central air and floor vents, consider using vent deflectors to direct and increase the reach of cooled air.
- Operate major appliances during the cooler parts of the day. Energy is conserved by using appliances like clothes washers and dryers early in the morning or late in the evening when there is less demand on the electric system.
- Switch to ENERGY STAR® certified LED lights. The energy-efficient bulbs run cooler and last up to 25 times longer than incandescent lights.
- Set ceiling fans to rotate counterclockwise and at a higher speed in the summer to circulate the breeze more effectively, creating a cooling, wind chill effect. Remember to turn the fan off when leaving the room.
- Look for the ENERGY STAR rating when purchasing new appliances. Also, be sure to choose the right size when purchasing an air conditioning unit. An oversized or undersized AC unit is less effective and uses more energy.

Help is available for customers who need it:

Eversource encourages customers to enroll in one of its payment plans or assistance programs if they need help with their energy bill.

Budget Billing Plan – Customers can avoid seasonal spikes on their energy bill by paying a fixed amount each month based on their average annual usage through budget billing. **Discount Rate** – Customers that meet certain income guidelines may qualify for a discount on their monthly bill.

Flexible Payment Plans – Payment Plans are available to all customers to pay their past-due balance over a period of time and protect from service interruptions.

New Start – Income-eligible customers can reduce or eliminate their enrolled, outstanding balance in as little as 12 months when they make on-time monthly payments and Eversource will make up the difference.
