BUDGET COMMITTEE VACANCY

There is currently a vacancy for a five month volunteer, appointed position to the Fremont Budget Committee, through the March 2012 Town Meeting. In general, the position requires attendance at 14-18 evening meetings per year, busiest during the budget season between September and January annually; and quarterly the rest of the year.

The Fremont Budget Committee is accepting letters of interest from any Fremont resident who may have knowledge in financial matters or interest in such a position. A desire to serve the community and an interest in finances and budgetary matters of

the Town and School District are a must. You must be a registered voter in Fremont.

FREMONT HISTORY - BE A PART OF IT!

To quote a well-known American, "it takes a village" and as a charter member of Fremont Historical Society (founded in 1966), and reader of The Fremont Newsletter, this writer can attest that Fremont has and will always qualify as a "village" for whatever cause, need and endeavor arises. All persons living now in Fremont are or will be part of its history, whether one's family goes back several generations or has just arrived.

The Fremont Historical Society (FHS) desperately needs "village" help to continue its goals of education through its yearly four program meetings, special projects and events that help to maintain the Historical Museum. The building belongs to the Town but the interior maintenance, heat, electricity, security and insurance for the collection, is the responsibility of FHS and requires an income of roughly two thousand dollars (\$2,000) yearly. This Museum owes its existence to the dedication (and much work!) of the Town Historian. Dues, donations and the 2009 Fremont Festival (Fair) have carried these costs to this point but it is time to "refill the till." In order to have another fair or similar event at the Museum, requires an update in the building's electrical capacity as well as a 501 C 3 tax status, the application for which will cost \$500. With the 250th Anniversary of Fremont in 2014 fast approaching, committed committees are planning for these eventualities but help is needed. New members of FHS are needed in any capacity, supporters, strong people for event activities, to raise money and provide fun and thus a "village." January 9, 2012: Last day to request an absentee ballot from the Town Clerk's Office. The Office is open 8:00 am – 5:00 pm.

January 10, 2012: Presidential Primary Election Day. Voters may register to vote at the polls during polling hours 8:00 am – 7:00 pm. A valid driver's license or photo ID and proof of residency is required to register to vote. The deadline for the Town Clerk to accept completed absentee ballots that come through the mail by 5:00 pm.

DOG LICENSE REMINDER

The 2012 dog license tags will be available beginning Tuesday, January 3, 2012. A current rabies certificate is required for licensing your dog(s) as the Clerk's Office is required by law to retain a copy of the vaccination certificate. Please call the office to inquire if the rabies certificate on file is still valid. You must license your dog(s) by April 30th to prevent the initiation of a late penalty of \$1.00 per month. As required by RSA 466:1, all dogs must be licensed each year by April 30th. For your convenience, the license(s) can be mailed for an additional fee of \$1.00 per license or you can license

your dog(s) online by going to the Town Clerks page on the Town's website at Fremont.nh.gov and click E-Dog. If you no longer have your dog, please contact the Clerk's office at 895-8693 so we can update our records accordingly.

PUBLIC HEARING

In accordance with NH RSA 675:6 and 675:7 you are hereby notified that the Fremont Planning Board will hold a Public Hearing on Wednesday December 7, 2011 at 7:30 pm in the basement meeting room of the Fremont Town Hall to review proposed changes and amendments to Articles IV-A, IX-E:4 (d) and XIX,1.3-C the Fremont Zoning Ordinance. A second Public Hearing, if it is necessary, will be held on Wednesday December 21, 2011 at 7:30 p.m. in the basement meeting room of the Fremont Town Hall. These proposed zoning amendments include:

Amendments to <u>ARTICLE IV-A</u> of the Fremont Zoning
Ordinance (In-Law Accessory Apartments)

Ordinance (In-Law Accessory Apartments).1. Delete the second portion of the sentence in section G.

"Any new entrances shall be located on the side or rear of the building and shall be at ground level".

2. Delete section H in its entirety. "All in-law/accessory apartments shall have accessible entrances and shall conform to dwelling unit Type-B construction, as specified in the International Residential Code (IRC).

 Amendment to Article XI –E; 4 (d) of the Fremont Zoning Ordinance (Aquifer Protection District) by adding "except for propane and natural gas".

 Amendment to Article XIX, 1.3-C of the Fremont Zoning Ordinance (Signs) - "For Sale Signs" by adding "and do not exceed six (6) square feet in size".

This full text of all proposed zoning amendments is posted at the Fremont Town Hall, Library, Safety Complex, and Post office, and on the Fremont Town web site. They are also on file in the offices of the Selectmen, Planning/Zoning and Town Clerk and can be viewed during regular business hours.
