Blue Christmas - A Service of Comfort and Hope at Peoples UMC, Fremont, NH on Sunday, December 11th- 5 pm

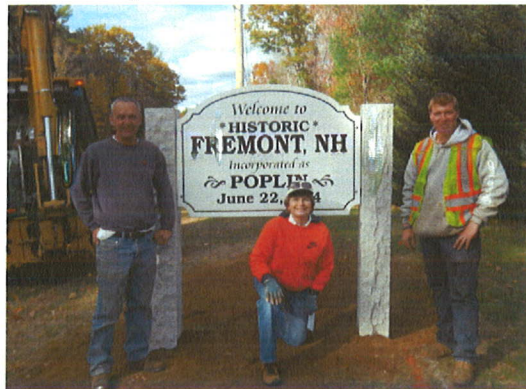

WINTER PARKING BAN IN EFFECT

According to the Town of Fremont Parking Ordinance: It shall be unlawful for any person to stop, stand or park a motor vehicle at any time contrary to any of the following provisions of this Section unless otherwise directed by a Police Officer.

1. Within the Town of Fremont, from November 15 to April 1, no parking is permitted on any public street or any town-owned right of way, or in any town-owned parking lot between 12:00 midnight and 6:00 am.
2. In the event of a winter snowstorm requiring snow plowing and/or removal as deemed necessary by the Fremont Road Agent, it shall be unlawful for any person having custody and/or control of any vehicle to park or cause the same to be parked within the public right of way, or on any public street or any town-owned right of way during a snow storm. Vehicles interfering with snow plowing or removal operations shall be towed at the owner's expense.

Penalty: A person violating any provision of this Ordinance shall be punished by a fine or not more than one hundred (\$100) dollars for each offense, except that optional procedures set forth in this section may be used in lieu of court proceedings for violations of this Ordinance.

CYCLICAL ASSESSING UPDATES

The Town's new assessing contract includes provisions to do cyclical updates. This means that 1/4 of the Town will be reviewed each year (data and listing information) toward the end goal of the every fifth year revaluation/recertification process required by the State. This means that assessors will be out in the field more often looking at all of the housing stock. They will update photos and listing information, and will ask to view your home if you are there

when they visit. This is at the owner's discretion, but is most helpful to the Town to ensure we have the best, most up to date information to arrive at your assessed valuation.

They are beginning this summer with data review of manufactured homes and condominiums. MRI personnel are in the field working on these properties, and they carry MRI Photo Identification and have with them, a letter from the Town (signed by the Town Administrator Heidi Carlson or Selectmen's Clerk Jeanne Nygren) with their name and vehicle information including license plate number. Currently Jerry Quintal and Dan Scalzo are working in Fremont collecting the data. The Selectmen's Office will always know when they are working in Fremont, so please feel free to call us if you have any questions. SOUTHERN NH DROUGHT

The drought in Southeast New Hampshire continues, despite some long overdue rains. Rockingham County continues to see these conditions, and we need to continue to conserve and be cautious about our water use to ensure we can make it through the winter. As soon as the ground freezes, water will not penetrate the ground, potentially until spring.

Fremont Public Officials continue to urge residents to conserve water as much as possible, and eliminate all unnecessary outside water usage. Saving water for essential uses such as fire suppression, drinking, cooking, sanitation and cleaning of clothes and dishes is paramount.

You may know that Fremont has a great deal of wetlands and an extremely large aquifer, but all of these resources are also being depleted during these drought times. We must be cognizant of the decreased water resources and do what we can to conserve and preserve as much as possible to get us through this low point until we see significant rains. We still need several inches of rain before the ground freezes, to recover to normal water levels.

INVOLUNTARILY MERGED LOTS

If you own real estate lots that were involuntarily merged by municipal action, you may be able to have those lots restored to their pre-merger status.

Your property may qualify if two or more lots were merged for zoning, assessing, or taxation purposes and the merger occurred:

- During your ownership, without your consent; or
- Prior to your ownership, if no previous owner consented to the merger.

To restore your property to pre-merger status, you must:

- Make a request to the local governing body
- No later than December 31, 2016.

Once restored:

- Your properties will once again become separate lots; however, they must still conform to applicable land use ordinances. Restoration does not cure non-conformity.

ROADS & the RIGHT-OF-WAY

Obstructions in the Town's right-of-way are not permitted. Plantings, mulch, trees, rocks, and decorative pavers ARE NOT PERMITTED. These structures of any size obstruct drainage from the roadway and cause other road problems. Please help keep the ROW clear of all obstructions. This includes toys, basketball hoops and the like.

RSA 236:15 states that any building, structure or fence within or over any highway is a public nuisance. Please do not place any such items in the right-of-way as they are subject to being removed by the Highway Department. In general, the Town right of way is 13 feet on either edge of the paved surface.

No objects can be stored or parked in the ROW, including vehicles, trailers or equipment, and personal property.

Please also remember if paving or repaving your driveway, you need a Town Permit for Driveway Paving. These can be found on the Town's website or are available from the Selectmen's Office. The permitting process is to ensure proper drainage and a connection to the Town Road where your driveway is. If you live on a State road, you would contact NH DOT at 603 868 1133 for a driveway permit. You do not need a permit to sealcoat your driveway.

TOWN HALL BASEMENT RENOVATIONS UNDERWAY

As you may know, finishing space in the basement of the Town Hall has been on the Town's agenda for nearly 20 years. We have saved money in Capital Reserve for 15+ years and have begun doing this work over the past 12 months. The time has come for the work to accelerate so that we can complete the heating system and accommodate the public and our meetings and work spaces.

The basement entry door has been relocated to the rear of the building, just past the old door location and left at the end of the building. This is how you get in to the Planning and Building Offices. These offices will be moving temporarily in coming months (within the basement area) so please watch for signage and be careful in this work area.

Meetings held in the basement meeting room are being moved to other meeting rooms as work progresses, so please check the meeting calendar on the website for the most up to date locations. We are still scheduling these meeting locations and will update the calendar regularly as changes are made. A notice is also posted on the homepage of the website at www.Fremont.nh.gov and this page will be updated as information or locational changes are made.

Live broadcasting of meetings may be reduced short-term, but we will bring you as much as possible by taping in other meeting rooms, or remote broadcasting from locations such as the Fremont Library.

We appreciate your patience as this long-awaited work comes to fruition!
