#### BOSTON POST CANE PRESENTATION

Ethel Edna Tilley, age 100, will be presented The Boston Post Cane on December 15 at the Wreaths of Remembrance ceremony. The Boston Post Cane was established by the Boston Post in 1909 by Edwin Glaiser, the owner of Boston Post. He was eager to gain publicity for his newspaper and came up with the idea of the Boston Post Cane. He had 700 canes made for towns in Massachusetts, New Hampshire, Maine and Rhode Island to be awarded to the oldest living male resident, in 1930 the rules changed to allow women to hold the cane also. The original canes were made of ebony from the African Congo and the head of the cane is door knob shaped and rolled in 14k gold with the town name engraved on it. Ellen L. Horsburgh was the last resident to hold the Boston Post Cane.

# FREMONT PLANNING BOARD Public Hearing Notice for Zoning Ordinance Changes

In accordance with NH RSA 675:3, you are hereby notified that the Fremont Planning Board will meet on December 5, 2018 at the Fremont Town Hall basement meeting room, 295 Main Street, Fremont, NH 03044, at 7:00 pm to hold a Public Hearing for the following proposed amendments to the Zoning Ordinance:

- Article IV Section 403: This proposal includes amending the Adoption and Amendments Ordinance so that it is renamed the "Adoption, Amendments, and Definitions" Ordinance. This proposal also includes moving existing definitions in the Ordinance to this chapter and adding new definitions.
- Article VII: This proposal includes the following amendments to the Zoning Maps and Districts Ordinance:
  - Changes to the district boundaries to appear on the Fremont, NH Zoning District Map (Article 7, Section 701-703). The extent of the changes can be viewed on the proposed Zoning District Map.
  - Renaming the Corporate-Commercial Zoning District to the Shirkin Road Commercial District.
  - Renaming the Commercial-Highway District to the Main Street District.
  - Including existing Conditional Use Permit criteria for certain uses in the Commercial- Highway and Corporate-Commercial Districts for clarity.
  - Expanding the Commercial-Highway District to extend onto portions of Red Brook Road, Danville Road, and on the northern side of Main Street towards the Brentwood/Fremont town line.
  - Addition of a "Residential District" that is currently undefined in the existing zoning. Allowed uses include residential uses and agricultural uses. The proposal includes a Conditional Use Permit requirement and criteria for establishing multi-family housing within the Residential District.
  - Addition of criteria for issuing a Conditional Use Permit for commercial uses within the Flexible Use District.
  - Better representing on the Zoning District Map which parcels are within the proposed Flexible Use District.
- Article VII Section 708: This proposal includes the following:
  - Clarifying which uses are permitted, permitted by Conditional Use Permit, or prohibited.
  - Renaming the Zoning Districts as reflected in the proposed zoning district amendments.
  - Replace the existing table of uses (originally from the International Building Code Use Categories) with a simpler list of uses. The overall intent was to maintain the same allowed uses/prohibited uses. The exception is that currently airfields, heliports and aircraft hangers are currently permitted or permitted with a conditional use permit in some districts. These uses have been removed from the list and would be considered "prohibited" unless they were considered accessory uses/structures to a principle use/structure.

A copy of this language is available upon request at the Fremont Town Hall during regular business hours. The final form of these amendments will be on the Warrant Article at the March 2019 Town Meeting. You are invited to attend this Hearing in person or by counsel or agent. #### WINTER PARKING BAN IN EFFECT

According to the Town of Fremont Parking Ordinance: It shall be unlawful for any person to stop, stand or park a motor vehicle at any time contrary to any of the following provisions of this Section unless otherwise directed by a Police Officer.

- Within the Town of Fremont, from November 15 to April 1, no parking is permitted on any public street or any townowned right of way, or in any town-owned parking lot between 12:00 midnight and 6:00 am.
- 2. In the event of a winter snowstorm requiring snow plowing and/or removal as deemed necessary by the Fremont Road Agent, it shall be unlawful for any person having custody and/or control of any vehicle to park or cause the same to be parked within the public right of way, or on any public street or any town-owned right of way during a snow storm. Vehicles interfering with snow plowing or removal operations shall be towed at the owner's expense.

Penalty: A person violating any provision of this Ordinance shall be punished by a fine or not more than one hundred (\$100) dollars for each offense, except that optional procedures set forth in this section may be used in lieu of court proceedings for violations of this Ordinance.

#### WASTE MANAGEMENT

The Town's contract with WM expires this year and a proposal for bids was advertised in September. Waste Management and Casella Waste Systems both submitted bids. The processing costs were:

WM Processing cost: \$102.67 Casella Processing cost: \$126.39

WM annual increase fixed at 3% Casella annual increase collection fixed at 5% and processing minimum of 3%

Based on the bid amounts the collection for 1 year would be:
Waste Management: \$243,816
Casella Waste System \$257,000

Recycling has become a challenge as there is less of a market for recyclables now. The most important thing with recycling is to not contaminate the recycling with other items that are no longer accepted. Please review the acceptable items carefully.

#### **WASTE MANAGEMENT RECYCLING**

Recently Waste Management has reached out to let the Town know of some changes that have been made regarding the items we recycle. When we export the recycled items, there is a stricter quality control needed and Waste Management will be checking the quality of items. Recently we were given a new Acceptable Materials List, simply stated they accept Plastic Bottles and Containers, Tin and Aluminum Cans, Beverage Cartons, Paper, Cardboard and Glass Bottles.

Nothing else should go in the recycling bin, especially plastic bags, even if they have the recycling emblem on them. We also recently learned that flower pots, and the plastic "six pack" that annual flower come in, are also NOT recyclable even if they show the recycling symbol. This has to do with size and processing limitations. Styrofoam of any form is not recyclable.

We appreciate your cooperation, as the more we can properly recycle, the more we can reduce our tipping costs at the landfill.
