Report of the Planning Board

As with 2009, the economy remained depressed in 2010 and the Planning Board focused its efforts on planning activities such as updating Master Plan chapters and various regulations.

The Planning Board, with the assistance of the Rockingham Planning Commission and the Fremont Land Use Office, has applied for, and obtained several grants that allowed the Board to update a number of Master Plan Chapters, obtain a Build-out Analysis of the Town, and create an Open Space Plan, all at no cost to the Town. The awarded grants are listed below.

In addition, the Board is currently conducting an audit of the Master Plan funded with CTAP Phase II funds (\$3,500), and the Board proposes to update the Vision Chapter of the Master Plan with a Targeted Block Grant through the Office of Energy and Planning.

The Rockingham Planning Commission receives grant monies annually from the NH Office of Energy and Planning to use for regional planning projects. This Targeted Block Grant (TBG) is in the form of a 50/50 matching program, in the range of \$1,000 - \$3,000 per community. The Town is required to formally apply for this grant and ensure that the local match is available as budgeted funds. The Fremont Planning Board ensures that it has the necessary budgeted funds available each year, and has successfully secured the following funding:
